Statement by Austria

regarding ITER climate contributions on items 2a (Multiannual Financial Framework 2021-2027 and Recovery Package – MFF 2021-2027 Regulation) and 2b (Multiannual Financial Framework 2021-2027 and Recovery Package – IIA)

"The Commission's declaration regarding climate contributions per programme indicates the following for the „International Thermonuclear Experimental Reactor“ (ITER): an expected contribution of 100% in view of achieving an overall target of at least 30% of the total amount of the Union budget and NGEU expenditures. In this context, Austria recalls that the targets in sectoral legislation/programmes shall comply with the objective of EU climate neutrality by 2050 and contribute to achieving the Union's new 2030 climate targets. However, ITER will not contribute to achieving the Union's new 2030 climate targets and the objective of EU climate neutrality by 2050 as the research and experimental reactor will not produce any electric energy within the next years. Likewise, even the follow-up project DEMO (DEMONstration power plant) will not yet be in a position to contribute to the goals of the Paris Agreement. It will rather lead to a net negative effect in CO² emissions during its construction.

Given,

- that the European Court of Auditors has highlighted that the EU climate coefficients applied in certain areas failed to respect the conservativeness principle developed by the World Bank and
- that these coefficients also diverge from the OECD classification framework and
- don't account for the negative impacts of investments,

EU expenditure for ITER should not be counted as a contribution to the overall climate target of 30%."

Statement by Hungary

"In light of the following reasons, Hungary votes against the decision:

First and foremost we do not support a favourable EU approach concerning recommendation 5.1. As was said at the third CND-intersessional meeting, the international efforts on pushing back drug consumption have been unsuccessful. It is especially true to cannabis-consumption, the rate of which has risen sharply over the last decades. The 3rd intersessional meeting also highlighted that the synthetic cannabinoids are starting to become the most popular type among new psychoactive substances.

The risk of misinterpretation of the potential deletion of cannabis and cannabis resin from Schedule IV cannot be prevented by any sort of follow up communication, because the recommendation in itself already constitutes communication: according to the WHO's rationale, new evidence proved that the inclusion of cannabis and cannabis resin to the Schedule IV. of the Convention was unjustified, because the health risks of cannabis is lower, and its medical benefits are higher than originally believed. The Hungarian Government strongly oppose this interpretation: the addictive potential of THC is being continuously proven by the sharp increase of cannabis use in the last decades. It should also be taken into account that the THC-concentration of cannabis-plants cultivated to illicit recreational use is constantly rising.

Additionally, the recommendation lacks added value: Today, research and development of cannabis-related preparations for medical use is also possible under the current Scheduling and cannabis containing medicinal products can be placed on the market as well. The WHO itself admitted during the technical discussion that obstacles in the field of research did not serve as a reason for the recommendation.

For the reasons above Hungary takes the view that Cannabis and cannabis resin should not be deleted from Schedule IV of the Single Convention on Narcotic Drugs (1961) until robust evidence is available regarding its therapeutic benefits.

In addition, the Hungarian Government cannot support the recommendation 5.4. We believe that the claim that the definition of "preparation" pursuant Article 1. point s) of the Single Convention on Narcotic Drugs covers all substances currently handled as "extracts and tinctures of cannabis" is not sufficiently substantiated. The approval of the recommendation 5.4 will force the State Parties of the Convention to change their national legislations and breach the relatively uniform framework of the international cannabis-control. Currently, cannabis and every substance produced from it shall be handled in the same way, regardless of its THC-concentration. Recommendation 5.4 will allow State Parties to change this practice. In our opinion, it is not clear that State Parties will continue to handle substances containing only traces of THC, or substances which do not contain THC but contain drug-precursors or stereoisomers that can be transformed into THC as cannabis-preparations. The WHO and the UNODC failed to provide sufficient reasoning to dispel this concern. On the contrary, Recital 21 of the draft resolution claims *"The fact that diverse preparations with a variable concentration of delta-9-tetrahydrocannabinol are controlled within the same entry 'Extract and Tinctures' and the same schedule is a challenge for responsible authorities that implement control measures in countries."* In our interpretation, it means that by the result of the recommendation, State Parties will actually gain some discretion over this matter. For the abovementioned reasons, the Hungarian Government consider that recommendation 5.4 – just like in the case of recommendation 5.5. – most probably will weaken the uniform application of the Convention.

Finally, we do not support recital 28 in whereby the EU initiates further consultation with stakeholders on a recommendation on the appropriate level of the international control for cannabis preparations with low THC content. We believe this proposal goes far beyond the objectives of establishing an EU position of the currently existing WHO-recommendations. We believe this question should be a subject to a separate discussion. "

Statement by the Commission

"The Commission will not oppose the adoption of the revised text of the Union position for the scheduling of cannabis and cannabis related substances at the reconvened 63rd meeting of the United Nations Commission on Narcotic Drugs (CND), but wishes to make the following statements:

1. The Commission reiterate its position that the decisions concerned by this proposal are adopted by qualified majority and are a matter of exclusive Union competence because Union law, in this case in the area of drug control, will be directly and automatically affected by the scheduling decisions of the United Nations Commission on Narcotic Drugs. The Commission underlines that this position refers to international scheduling decisions under the 1961 UN Convention on Narcotic Drugs and the 1971 UN Convention on Psychotropic Substances and not to drugs policy in general.
2. The Commission regrets the weakening of the text of recital 28 and the proposed deletion of the second part of point 5 in the Annex. While the scope of the compromise text is larger than the proposal of the Commission, the compromise text does not invite the WHO to urgently issue a revised recommendation for the revision of the level of international control for cannabidiol or cannabis preparations with low THC content. Such a revision is necessary to take into account the possible high value applications of cannabidiol, for example in the health, cosmetic and food sector, as well as the economic and environmental potential of industrial hemp cultivation. The Commission considers that the current status of cannabidiol needs to be addressed as soon as possible in view of the economic importance and environmental benefits of hemp production for EU producers."
