Subject:	Management Board of the European Institute for Gender Equality:
	Appointment of Ms Daniela KOŠECKÁ, alternate member for Slovakia, in place of Ms Lucia VLASÁKOVÁ, who has resigned

- 1. The General Secretariat of the Council has been informed of the resignation of Ms Lucia VLASÁKOVÁ, as alternate member of the Management Board of the European Institute for Gender Equality in the government representatives category (for Slovakia).
- 2. Article 10 of Regulation (EC) No 1922/2006 of 20 December 2006¹ provides, inter alia, that the Council should appoint eighteen members, as well as alternates, of the Management Board of the European Institute for Gender Equality for a period of three years. The appointed members and alternate members represent eighteen Member States in the order of the rotating Presidencies, one member and one alternate member being nominated by each Member State.
- 3. By its Decision of 24 May 2022², the Council appointed the members and alternate members for the period ending on 31 May 2025.
