### Statement by the Commission (on use of logo)

"The Commission regrets that the co-legislators decided to maintain the MEDIA logo. This runs counter to the horizontal approach of not having programme-specific logos under the future long-term budget. The Commission's intention is to make sure that Europeans can relate to the Union as a whole thanks to the use of the single European emblem by its different programmes. This emblem is common to all EU Institutions and will be an important part of the simple, coherent and binding communication and visibility requirements across programmes. For the sake of reaching overall agreement on the programme, the Commission can accept to maintain the MEDIA logo under the condition that it remains limited to the duration of the concerned programming period.

The Commission remains convinced that communication and visibility of EU action towards a broad public is more effective without any programme-specific logos. The Commission remains at the co-legislators' disposal to demonstrate this well ahead of the negotiations of the subsequent programming period."

### Statement by the Commission on European Union youth orchestra ('letter of intent')

"In the context of recital 23 and Annex I, Article 1, special actions e) as well as Article 7(5) of the above mentioned Regulation, as agreed by co-legislators on 14 December 2020, the European Commission confirms its intention to launch calls for proposals inviting applications for multi-annual operating grants to which the European Union Youth Orchestra and other entities could apply and which would provide the necessary stability for the functioning of these entities need. These calls will be subject to the adoption of work programmes, which will set out exact conditions, such as the timing of calls or the duration of grant agreements foreseen. The Commission further confirms its intention to launch the first of such calls in the 2021 annual work programme. This intention is subject to the adoption of the above-mentioned regulation and final agreement on the Union budget for 2021."

"The Commission takes note of the agreement of the European Parliament and the Council on the co-financing by Member States. While the Commission can accept that Member States' contributions are not specified as part of the Regulation, the Commission regrets the inclusion in the political agreement of the notion of 'voluntary' contributions from Member States to the extent that this does not demonstrate the long-term commitment of all involved parties.

The success of the Centre lies in the effective contribution by Member States, without which its mission would not be accomplishable.

The Commission clarifies that that the Union will contribute with funding from the Horizon Europe programme only as much as Member States are ready to commit on an annual basis. Furthermore, the Commission wishes to stress that once one or more Member States commit, such a commitment will be binding."

### Statement by Austria

"Austria supports the objectives to decarbonize road transport and to strengthen the polluter pays principle, and acknowledges that a revised Eurovignette Directive can contribute to reaching the Union's climate targets. In this sense, Austria welcomes the introduction of a CO2 modulation in the charging of heavy goods transport and the obligation to levy external costs in areas with significant environmental damage. Austria also recognizes that certain improvements with regard to mark-ups have been achieved, notably the possibility to levy mark-ups outside mountainous regions and in addition to external costs.

However, the text on mark-ups in Article 7f (1)(b) falls short of adequately addressing the dramatic congestion on the Brenner Alpine crossing, which has been a heavy burden for the population as well as the environment for many years. The possibility of applying a mark-up of 50% on routes that are regularly congested is of utmost importance for Austria. The new additional requirement to obtain the consent of all Member States which are part of that corridor and neighboring the Member States in whose territory the section of the corridor to which this 50% mark-up is applied falls, represents an unnecessary hurdle that would result in the provision never being applied in practice. It will have a negative effect on the European climate goals. It is therefore not acceptable to Austria.

In addition, Austria is of the opinion that the option of exempting vehicles between 3.5 t and 7.5t used for own-account in Art. 7(5)(ii) is a false signal and a deviation from the polluter pays principle, since those vehicles also contribute to environmental pollution. It is expected that such a provision – even if it is optional – will generate considerable pressure on Member States to implement it.

It must be our goal to adopt a Directive which in practice leads to a sustainable reduction of road freight traffic and contributes to a shift to rail, especially in light of the recently-agreed EU target of a net domestic reduction of greenhouse gas emissions of at least -55% until 2030 and the objective of a climate-neutral EU by 2050.

For the reasons outlined above, Austria does not see its ambition adequately reflected in the mandate, and therefore votes against."

### Statement by Belgium

"BE supports this negotiating mandate. However, BE would like to stress that regarding the optional exemption for own account transport in article 7(5)(ii) we expect the negotiations to lead to a clear definition on the possible beneficiaries. Such a measure is intended for small independents only, and abuse should be avoided. A clear and narrow definition must also prevent disproportionate and negative impact on the environment."

However, the Commission regrets the inclusion of the 'respect of human rights' in the set of criteria for third countries to fulfil in order to be eligible for association to the Programme under Article 12 (1) d. No other EU programme for the future Multiannual Financial Framework saw the need to include such an explicit reference, while there is no question that the EU is seeking to pursue a consistent approach in its external relations with third countries as far as Human Rights protection is concerned across all its instruments and policy areas, and which should guide the Commission in the implementation of this provision."

"The Council and the European Parliament agreed on a compromise text of the European Space Programme Regulation, which requires the Commission to inform them of the framework financial partnership agreement (FFPA) and the contribution agreements to be concluded and their implementation and of the work programmes. The agreed text provides that the Commission approves those agreements and the work programmes by means of implementing acts. Therefore, the Commission will fulfil its obligation to inform the European Parliament and the Council about the upcoming conclusion of the FFPA or of a contribution agreement or adoption of a work programme in compliance with the provisions on information on committee proceedings in Regulation (EU) No 182/2011 laying down the rules and general principles concerning mechanisms for control by Member States of the Commission's exercise of implementing powers."

"The Commission underlines that it is contrary to the letter and to the spirit of Regulation 182/2011 (OJ L 55 of 28.2.2011, p. 13) to invoke Article 5(4), subparagraph 2, point b), in a systematic manner. Recourse to this provision must respond to a specific need to depart from the rule of principle, which is that the Commission may adopt a draft implementing act when no opinion is delivered. Given that it is an exception to the general rule established by Article 5(4), recourse to subparagraph 2, point b), cannot be simply seen as a discretionary power of the Legislator, but must be interpreted in a restrictive manner and thus must be justified."

Statement by the Commission

"In respect of Article 1bis and recital 8, the Commission recalls that the division of competences as between the Union and the Member States is exhaustively dealt with in the Treaties, both for usual and exceptional circumstances. In accordance with the jurisprudence of the Court of justice, the legislator has no power to alter that division. Against this background, the Commission considers that this Regulation, as such, does not prejudge the nature of the future relationship with the United Kingdom in the area of aviation following its expiry. The exercise of competence through the Regulation is temporary and strictly limited to its period of validity.

This is without prejudice to the legal position following from the current or any future authorisations to negotiate, with any third country."

"Austria, Denmark, Greece, Italy and Spain support the objective of ensuring basic connectivity in road transport in the event of the United Kingdom and the European Union failing to conclude a new partnership agreement before the end of the transition period on 31st December 2020. We welcome the proposed temporary measures enabling road haulage, coach, and bus service operators licensed in the UK to carry goods and passengers to and from the EU Member States. As in 2019, these measures are necessary to prevent serious disruptions in the context of such operations immediately after the end of the transition period.

However, the situation as of 1 January 2021 is not comparable with the situation in early spring of 2019. All parties concerned and involved in the process of the UK's withdrawal from the EU have had ample opportunity to prepare for the inevitable changes resulting from the UK's decision to withdraw from the EU. Therefore, Austria, Denmark, Greece, Italy and Spain are concerned, that the scope of the initial proposal has been extended to include a certain number of cabotage operations in road freight. We are of the opinion that this extension of the scope is not in line with the guidelines on contingency measures agreed by the European Council on EU 27 general conduct, as these operations are not strictly necessary to ensure basic connectivity between the UK and the EU 27.

However, mindful of overarching economic concerns, Austria, Denmark, Greece, Italy and Spain understand that the rights granted to UK hauliers under the condition of reciprocity are a way of responding to the unique situation of a Member State leaving the European Union. Austria, Denmark, Greece, Italy and Spain stress that the phasing-out-condition of the rights granted in this Regulation builds an essential part of this Regulation. It is a measure taken to minimize the negative effects of the end of the transition period. However, we would like to point out that the right to perform cabotage operations within the EU is an exclusive right to its Member States and does not seem necessary in this situation.

Austria, Denmark, Greece, Italy and Spain believe that the rights granted to UK hauliers for a limited timespan under the condition of reciprocity are due to the unique situation of a Member State leaving the Union. This Regulation will not preempt further negotiations with the UK or other third countries and will not be considered as a precedent."

The Committee agreed on the negotiating mandates for the three files. In addition the Committee agreed to use the written procedure for the adoption of the files if the EP approves the three files in a version identical to the Council's mandate. The Committee also agreed to derogate from the eight-week period provided for in Article 4 of Protocol 1 on the role of national parliaments in the EU.

Joint statement by Austria, Belgium, Denmark, Finland, France, Ireland, Italy, Malta, Luxembourg, Spain, Sweden, and the Netherlands on gender

"Austria, Belgium, Denmark, Finland, France, Ireland, Italy, Malta, Luxembourg, Spain, Sweden, and the Netherlands strongly believe that the text on gender equality should reflect the agreed language to the achievement of the Union's policies on gender equality and the work towards a gender-equal Europe. Reference to 'equality between women and men' instead of 'gender equality' is inappropriate when reference is made to the overall Union's policy."

Joint statement by Austria, Denmark, Ireland, Sweden and the Netherlands on capital support

"Austria, Denmark, Ireland, Sweden and the Netherlands would have preferred that the Presidency had brought the compromise text regarding capital support back in line with the Council mandate, since:

- The possibility to provide capital support is not in line with the European Council conclusions in July (no solvency support instrument). Also, there is ambiguity on the adequate provisioning rate in case of solvency support and the consequences and risks for the InvestEU programme, the EIB, and subsequently Member States when this provisioning rate is not adjusted for solvency support;
- The possibility to transfer resources from the RRF in order to provide capital support in InvestEU is not in line with the objectives of the RRF as stated in the European Council conclusions. In addition, the conditions and implications of such a transfer remain unclear.

Furthermore, we have concerns regarding the combination of relevant portfolios of financial instruments established under the 2014-2020 Multiannual Financial Framework and the EU guarantee under the EFSI Regulation with the EU guarantee under the InvestEU. It is important that this does not create a precedent for the treatment of reflows from financial instruments and that any surplus of provisions for a budgetary guarantee like the EFSI and InvestEU are returned to the budget in line with the Financial Regulation, and budgetary decisions should, as a matter of principle, be part of budget/MFF negotiations."

#### Statement by Poland

"Equality between women and men is enshrined in the treaties of the European Union as a fundamental right. Commission statement on the Amendments to the Prospectus Regulation (CMRP)

"The Commission takes note of the fact that the political agreement on the Commission proposal to amend the Prospectus Regulation in order to introduce an EU recovery prospectus includes an amendment to the Transparency Directive postponing the requirement to prepare financial reports using the European Single Electronic Format (ESEF). This postponement was not included in the initial proposal of the Commission. In the Commission's view, the postponement of ESEF is not in line with the EU's better regulation principles and the Commission's right of initiative. It should not, therefore, constitute a precedent. As the postponement of ESEF is not a substantive change of policy and reflects the difficult circumstances that companies face due to the Covid pandemic, the Commission will not stand in the way of its adoption."

### Statement by Austria

"Austria is against the Regulation for the following reason:

1. Threefold increase of maximum residue levels (MRLs) for fluxapyroxad in "other root and tuber vegetables except sugar beet" is in contradiction to the "Farm to Fork" strategy where the use and risk of pesticides should be reduced significantly by 2030.
2. GAP compliant residue data for fluxapyroxad in radishes would allow a lower MRL for radishes.
3. The application for import tolerance for fluxapyroxad in artichokes is not justified as MRL in country of origin is lower."
