14362/23 AN/io 1 LIFE.1 **LIMITE EN** In general, Czech republic supports the suggested amendments of the Breakfast directives. We would like co clarify our position regarding proposed honey labeling. Czech republic agrees with the mandatory indication of the countries of origin for honey mixtures on the product label. However we cannot support the proposal at the moment, until laboratory methods for verification will be developed. We believe that some other member states (DE, NL, FI, CY, FR, IE) also share similar opinion according to their position presented this week at the SCA meeting. Comments from Czech republic in the case of the Breakfast directives

Honey

- Czech republic agrees with the mandatory indication of the countries of origin for honey mixtures on the product label.
- However, we disagree with the additional requirements indication of percentage of honey of all countries of origin in descending order, because there is currently no possibility of direct verification by laboratory methods. This will only bring additional administrative burden for both supervisory authorities and manufacturers.
- Administrative verification by the supervisory authorities is currently underway, however the effects on the quality of the honey are debatable.
- Therefore, we cannot support the proposal to indicate the percentage of all countries of origin
 where the honey has been harvested, in descending order by weight, together with the
 percentage that each of the country represents.

Small honey packages

 Czech republic agrees with the proposed way of labeling the countries of origin for small honey packages in the form of two-letter codes, in accordance with the latest version in force of the international standard ISO 3166-1.

Analytical methos for detecting honey adulteration

Regarding the issue of honey adulteration, in our opinion, we see it as appropriate to include
in the text a four-year period in which the Commision will use its mandate to develope
analytical methods to detect adulterated honey.

Fruit juices

- From the options presented, which relate to the claim about the presence of sugar in fruit juices, Czech republic supports the variant of the claim "no fruit juices contain added sugars".
 We consider this variant to be clearer and more comprehensive for the average consumer.
- Czech republic can express its consent to the Commision being empowered to create an implementing act for the regulation that would concern fruit juices with a reduced sugar content.

Fruit jams/Extra Jams

 Czech republic can also support the proposed compromise regarding the increase of fruit content in Extra jams.

Milk

 Regarding the milk directive, Czech republic agrees with the proposal and has no additional comments.
