Subject:	Draft Agreement on the European election recess period in 2024 for the transmission of delegated acts and draft measures adopted under the regulatory procedure with scrutiny - Approval of a letter

1. The Common Understanding on delegated acts establishes, in paragraph 14, that “by October of the year preceding the elections to the European parliament, the three institutions shall agree on an arrangement for the notification of delegated acts during the election recess”¹.
2. On 29 September 2023, the Commission submitted to the European Parliament and to the Council a draft agreement on the European election recess period in 2024 for the transmission of delegated acts and draft measures adopted under the regulatory procedure with scrutiny².
3. By letter of 24 October 2023³, the President of the European Parliament informed the Council that the Conference of Presidents of the political groups of the European Parliament endorsed the draft agreement at its meeting of 19 October 2023.

4. At its meeting on 6 November 2023, the Working Party on General Affairs examined the draft agreement and agreed to forward the text to the Permanent Representatives Committee for approval.

 - approve the text of the draft agreement on the European election recess period in 2024 for the transmission of delegated acts and draft measures adopted under the regulatory procedure with scrutiny as set out in doc. 13316/23, and
 - approve, in accordance with Article 19(7)(k) of the Council's Rules of Procedure, the letter to the President of the European Parliament, as set out in the Annex to this note, in reply to her letter of 24 October 2023.
