THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Regulation (EC) No 2100/94 of 27 July 1994 on Community plant variety rights¹, and in particular Article 47(1) thereof,

Having regard to the list of candidates proposed by the Commission on 13 October 2021, after obtaining the opinion of the Administrative Council of the Community Plant Variety Office,

Whereas:

- (1) By Decision of 16 June 2016², the Council renewed the term of office of Ms Sari Kaarina HAUKKA as alternate to the Chairperson of the Board of Appeal of the Community Plant Variety Office.
- (2) The term of office of Ms Sari Kaarina HAUKKA expired on 14 October 2021.

HAS ADOPTED THIS DECISION:

Article 1

1. Mr Marcus NAVIN-JONES is hereby appointed alternate to the Chairperson of the Board of Appeal of the Community Plant Variety Office (the 'Office') for a period of 5 years.
2. The term of office of Mr Marcus NAVIN-JONES shall run from the date on which he takes up his duties. This date shall be agreed between the President and the Administrative Council of the Office.
