<u>The Committee</u> discussed key political issues (the starting date of the scheme for aviation and the percentage of allowances to be auctioned) relating to the proposal to include aviation activities in the EU emission trading scheme, with a view to giving a mandate to the Presidency to negotiate with the European Parliament a first reading agreement. <u>The Committee</u> could not agree on such a mandate. The Presidency will continue the work at the Working Party level in order to reach a political agreement on this proposal in the (Environment) Council, on 20 December 2007.

The Committee agreed on the text of Chapters II and III of the abovementioned draft Council Decision establishing the European Police Office, pending a Czech Parliamentary reservation and an Irish scrutiny reservation. It also took note of an Italian suggestion to amend Article 10 (2), as set out in document 14593/07 EUROPOL 113.

<u>The Committee</u> reached agreement on the Implementation Plan as set out in document 14590/07 EUROPOL 112 and agreed to submit it for endorsement to the Council.

- b) Draft Council Decision on the implementation of Decision on the stepping up of cross-border cooperation, particularly in combating terrorism and cross-border crime
 - **Outstanding issues** 14310/07 CRIMORG 163 ENFOPOL 177

The German and French delegation lifted their reservation on Article 11 and 12, subject to the addition of a new recital. Also, a political declaration would be proposed by these delegations concerning the systematic comparison of DNA profiles, to be added to the Council minutes.

The Austrian delegation welcomed this addition but could not lift its reservation (AT informed the Presidency on 5 November that it withdrew its reservation).

Following some discussion, the Netherlands delegation lifted its reservation on Article 16(5), subject to an amendment in Article 19(1) so that the actual use of Article 16(5) be closely monitored.

<u>The Committee</u> agreed on an amendment proposed by the Polish delegation for Article 17a (1) and (2).

Finally, the Hungarian and Czech delegations lifted their reservation on Article 17a(3) and Article 18b respectively.

The document would therefore be submitted to the Council, requesting the Council to endorse the general approach.

Draft Council Decision on the improvement of cooperation between the special c) intervention units of the Member States of the European Union in crisis situations

General Approach 14312/07 ENFOPOL 178

The Committee agreed on the general approach for the above-mentioned Council Decision, subject to a study reservation of the Finnish delegation.

This delegation would endeavour to lift its reservation as soon as possible and would inform the Presidency thereof (this was done on 8 November 2007).

The document would therefore be submitted to the Council, requesting the Council to endorse the general approach.

The Council Conclusions on combating Cybercrime, document 13893/2/07 REV2 CRIMORG 148 CATS 110, were adopted by the Committee with a change requested by the Spanish delegation. The wording of conclusion No 4 on page 5 has been changed in order to state that implementation of the measures of the Council of Europe Convention on Cybercrime is supported and encouraged (document 13893/2/07 REV 2 COR 2).
