The purpose of this transfer is to move an amount of EUR 2.83 million in commitment appropriations from Article 30 04 02 (*Reserve for the European Globalisation Adjustment Fund for Displaced Workers (EGF)*) to Article 16 02 02 (*European Globalisation Adjustment Fund for Displaced Workers (EGF)*), as recorded in document 14105/23.
- 3. The <u>Budget Committee</u> examined the proposal for a transfer at its meeting on 24 October 2023.
- 4. Following that examination, the <u>Budget Committee</u> agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
 - the proposed transfer of appropriations, as set out in document 14105/23; and
 - the draft letter in the ANNEX to that effect.
