Subject:	Transfer of appropriations No DEC 18/2023 within Section III - Commission - of the general budget for 2023

 On 20 October 2023, <u>the Commission</u> submitted to the Council proposal for transfer of appropriations No DEC 18/2023, in accordance with Article 31(1) of the Financial Regulation¹.

The purpose of this proposal is to transfer a total amount of EUR 13.9 million in commitment appropriations from Article 03 05 01 (*Cooperation in the field of customs (Customs)*), as well as Items 03 10 01 01 (European Chemicals Agency -- Chemicals legislation) and 03 20 03 01 (*Procedures for awarding and advertising public supply, works and service contracts*) to Item 02 04 06 11 (*Semiconductors -- Chips Joint Undertaking*), as recorded in document 14471/23.

- 2. The transfer is being proposed in order to finance the activities of the Chips Joint Undertaking, as foreseen in the political agreement reached on the Chips Act in April 2023.
- 3. <u>The Budget Committee</u> examined the proposal for a transfer at its meeting on 24 October 2023.
- 4. Following that examination, the Budget Committee agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
 - the proposed transfer of appropriations, as set out in document 14471/23; and
 - the draft letter in the ANNEX to this note.
