STATEMENT 109/00

"The Council and the Commission state that in the revision of the Common Fisheries Policy special attention will be paid to the fisheries situation in the Mediterranean, and in particular to the desirability of reviewing the technical conservation measures in force."

STATEMENT 110/00

Commission statement

"<u>The Commission</u> is pleased that the Council has adopted most of the European Parliament amendments accepted by the Commission. However, it regrets that the Council has decided not to adopt a number of amendments supported by the Commission."

STATEMENT 111/00

Statement by the German delegation

"The sector of non-Annex I goods is an extremely important and sensitive area in economic and in agricultural policy terms. In compliance with WTO commitments it is therefore necessary to proceed with extreme caution and do everything possible to ensure that the flow of exports of those goods is as steady as possible. It is a question of preserving the competitiveness of the EU processing industry on third-country markets. The production of added value and jobs must remain within the European Union.

The disadvantages arising from the reduction of the refunds budget must therefore be offset.

Offering the possibility of using inward processing arrangements without an examination of economic conditions in addition to the inward processing arrangements under Regulation (EEC) No 2913/92, which the Commission has guaranteed will be retained, is the right approach and should now be put into practice in the implementing rules.

The implementing rules must ensure that firms in the processing industry have access to raw materials on the world market in sufficient quantity and of sufficient quality to enable them to make reliable long-term calculations and to keep their administrative burden to a minimum.

Our opinion, and that of the majority of the European food industry, is that this can best be achieved by a system based on the value of raw materials.

The German delegation asks that this be taken into account as far as possible in the implementing rules.

On this understanding the German delegation approves the proposal for a Regulation."

STATEMENT 112/00

Council statement

"The Council requests the Commission to conduct a thorough analysis and to submit a report on the role, missions and respective powers conferred on national laboratories and Community reference laboratories."

STATEMENT 113/00

Council Statement

"The Council requests the Commission (in the context of the forthcoming review of Council Decision 90/424/EEC) to consider what should be done with animals which die in the course of an epidemic."

STATEMENT 114/00

Statement by the Greek delegation

"Greece, which has considerable experience in combating bluetongue and has achieved a certain degree of success in this area, hereby enters a reservation on the Commission proposal for a Directive as it considers that the effectiveness of some of the measures proposed is doubtful and is no longer fully borne out from a scientific point of view."

STATEMENT 115/00

Re Article 5(1)(e) and Annex III, strand 2.2

"The Council and the Commission state that in establishing criteria for annual support for non-governmental organisations (NGOs) involved in combating discrimination, the Committee will ensure that the opinion it delivers guarantees that the Community subsidy is as cost-effective as possible."

STATEMENT 116/00

Re Article 10

"The Commission states that the inclusion of an article on funding is inappropriate in this decision adopted in consultation with the European Parliament and it would refer to point 34 of the Interinstitutional Agreement between the European Parliament, the Council and the Commission of 6 May 1999 on budgetary discipline and improvement of the budgetary procedure to the effect that legislative instruments concerning multiannual programmes not subject to the co-decision procedure will not contain an "amount deemed necessary". The Commission therefore deplores the fact that the Council has included such a financial reference in a new Article and points out that it will be taken as illustrating the will of the legislative authority and will not affect the powers of the budgetary authority as defined by the Treaty."

STATEMENT 117/00

Re deleted Article on sanctions

"The Commission and the Spanish delegation wish to point out that although it is for the Member States to determine the penalties applicable to infringements of national provisions adopted in application of this Directive, those penalties must, in accordance with the case law of the Court of Justice, be effective, proportionate and dissuasive."

STATEMENT 118/00

Re information given by the Commission

"The Council takes note, in these minutes, of the information given by the Commission."

STATEMENT 119/00

Re information given by the Commission

"The Commission provided this information – on the basis of information given by the social partners – solely to facilitate discussions. This information in no way constitutes interpretations of the Agreement."

STATEMENT 120/00

Re Article 3(1)

"The Commission is not opposing limitation of the scope of this Regulation to activities all or part of which fall within the scope of Community law solely in order to ensure that it is approved at first reading, in view of the importance of swiftly introducing appropriate rules for the processing of personal data by the institutions and bodies of the European Community.

<u>The Commission</u> notes that personal data are processed by the institutions under Titles V and VI of the Treaty on European Union. It considers it necessary to make such processing subject to clear and certain legal rules on the protection of personal data.

<u>The Commission</u> asserts that such rules can be adopted on the basis of Article 286 of the Treaty establishing the European Community. It considers that this basis covers the processing of data by Community institutions and bodies in all cases where they act, including the case of activities under Titles V and VI of the Treaty on European Union. It does not therefore agree with the Council's interpretation that Article 286 of the Treaty establishing the European Community covers only the activities governed by that Treaty.

<u>The Commission</u> reserves the right to submit other legislative initiatives to that effect. It also reserves the right to make the processing of personal data by the Commission in the context of activities under Titles V and VI of the Treaty on European Union subject to the principles contained in this Regulation until rules applicable to such processing have been established."

STATEMENT 121/00

Re SECTION 2 (Articles 5 to 8)

"The Austrian delegation is of the opinion that the provisions of Article 5, in conjunction with Article 8, and of Article 6(1) and Article 7(3) limit the legal use of data in a manner which is not required by Directive 95/46/EC. Accordingly, these provisions cannot be considered either as a benchmark for the implementation of the above Directive or as a precedent for future national provisions."

STATEMENT 122/00

Re SECTION 2 (Articles 5 to 8)

"The German delegation considers that the Directive does not require the specified purposes to be observed strictly and without exception and that, therefore, Article 6(1) and Article 7(3) cannot serve as a criterion on for the transposition of the Directive and do not constitute a precedent for future legislation."

STATEMENT 123/00

Re Article 28(2)

"The European Supervisor is responsible for monitoring application of Community acts of the Institutions on the protection of personal data. His opinion is therefore important for the legislative process. However, it is also essential that <u>the Commission's</u> right of legislative initiative should be respected. Consequently, Article 28(2) must be interpreted as imposing an obligation to consult the Supervisor only after adoption of the Commission proposal."
