- Approval of final compromise texts

The SCA approved the consolidated draft Regulations set out in documents 13294/1/13 REV 1 + COR 1, 13349/1/13 REV 1 + COR 1, 13387/1/13 REV 1 and 13369/1/13 REV 1 as well as the additional Council Statements on Article 43(3) TFEU and on the non-opinion clause as amended during the meeting (see doc 7696/1/13 REV 1).

The SCA authorised the Presidency to inform the Chairman of the EP's Committee on Agriculture and Rural Development in writing that, if the EP could adopt the amendments to the Commission proposals as set out in those documents at first reading, the draft Regulations would, subject to legal-linguistic revision, be acceptable to the Council.

The Cyprus delegation provided the following statement:

"The Cyprus Delegation considers excessive and unjustified the reduction of its national financial allocation for rural development by 30% compared to the 2007-2013 envelope which was already reduced contrary to all other new member states. Cyprus was expecting an increase based on objective criteria in previous scenarios and reiterated the need for remedial action at some point in the future."
