THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Article 207(3) and Article 207(4), first subparagraph, in conjunction with Article 218(6), second subparagraph, point (a) thereof,

Having regard to the proposal from the European Commission,

Having regard to the consent of the European Parliament¹,

Whereas:

- (1) In accordance with Council Decision (EU) .../...²⁺, the International Coffee Agreement 2022 (the ‘Agreement’) was signed on ...⁺⁺, subject to its conclusion at a later date.
- (2) Pursuant to the Agreement, the Union should, upon approval, declare its exclusive competence over matters governed by the Agreement and deposit a declaration with the Depositary.
- (3) The Agreement and the Declaration of Competence attached to this Decision should be approved,

DECLARATION OF COMPETENCE OF THE EUROPEAN UNION
IN ACCORDANCE WITH ARTICLE 44(4)
OF THE INTERNATIONAL COFFEE AGREEMENT 2022

In accordance with Article 44(4) of the International Coffee Agreement 2022, the European Union declares that, in accordance with the Treaty on the Functioning of the European Union, the matters governed by the Agreement fall within the exclusive competence of the European Union under the common commercial policy and the Member States will therefore not be ratifying the Agreement.
