	- Preparation for the trilogue

- 1. In view of the third trilogue on 12 December, delegations will find attached a revised 4-column document reflecting the state of play of negotiations on the Creative Europe programme¹ as prepared by the Presidency. The document is based on the interinstitutional technical meeting held since the second trilogue (26 November), namely on 3 December as well as the discussions in the Cultural Affairs Committee (CAC) on 2 and 4 December (the latter meeting being held in an attaché format).
- 2. The 4th column of the attached document includes the elements agreed at the second trilogue² and the items on which a preliminary agreement has been reached since the second trilogue (namely lines 49, 77, 78, 94, 126, 162, 165, 170, 180, 181, 182, 183, 256, 268, 280, 294 and 303)³.
