Having regard to the Article 27(5), second sub-paragraph of the CDE's Financial Regulation, <sup>1</sup>

### Whereas:

- (1) The revenues of the Centre for the financial years 2011 and 2012 consisted of contributions from the European Development Fund amounting to EUR 17 850 484,11 for 2011 and EUR 15 856 427,31 for 2012;
- (2) The Director's overall implementation of the Centre's budget during the financial years 2011 and 2012 was such that, on the basis of the financial statements and the statutory audit reports of the Centre for the Development of Enterprise for 2011 and 2012, he should be given a discharge in respect of the implementation of those budgets,
