"Ireland welcomes the progress made in negotiating a draft Joint Declaration for the Eastern Partnership Summit (15 December 2021) and in particular the foregrounding of values in our engagement with the partner countries concerned. Nonetheless, we remain deeply concerned in relation to attempts to erode agreed EU language around human rights, in particular relating to gender and the rights of women and girls. On paragraph 11 of the draft Annex, we are strongly of the view that the term 'gender identity' should be retained in the text, and recall that this term is already agreed EU language as reflected in February 2021 Council Conclusions on EU Priorities in UN Human Rights Fora. On the Third Gender Action Plan (GAP III) we express our strong preference for the use of agreed EU language, as per the April 2021 Council Conclusions on a renewed Partnership with the Southern Neighbourhood. We also recall the important role that the Istanbul Convention plays in combating, preventing and prosecuting all forms of violence against women. We welcome the ambition in the Joint Staff Working Document which made clear the need to sign and ratify this Convention, and as this Convention is open for accession, it is important for the EU to encourage all states, including our Eastern Partnership partners, to become parties."

"In response to a question by Sweden as to what legal possibilities exist to take account of its position regarding the adoption of the draft Council decision, the Council Legal Service pointed out that the proposed assistance measure to support the armed forces of Mali does not concern lethal equipment, and this fact - i.e. that it concerns non-lethal equipment - is not disputed.

The CLS underlined that it is not possible for a Member State to use a "constructive abstention" under Article 31(1), second subparagraph, TEU as a way to avoid contributing financially to an assistance measure on non-lethal equipment. The only exception to the rule that all Member States contribute financially to assistance measures is the special case foreseen in Article 5(3) of the EPF Decision as regards the supply of lethal equipment, which also provides for a mechanism whereby the financial contribution will go to other - non-lethal - assistance measures.

It is of course always possible for a Member State to abstain when voting - through a "normal" abstention - to convey the political message that it does not vote in favour of a measure for whatever reason it may have."

Statement by Poland

on 29b): Regulation on digital operational resilience act

"In general Poland supports the proposed regulation. We believe that it can be a good basis for further negotiations with the EP.

Nevertheless, we would like to highlight an area that we believe needs to be worked out in the negotiations with the EP. PL would like to underline the necessity of alignment between DORA and the NIS2 provisions regarding the relation with sectorial regulation (lex specialis rules). When the NIS2 provisions on the lex specialis are agreed a thorough analysis should be made whether these two legal acts are aligned in a way ensuring that the DORA is considered as lex specialis to the NIS2, and if needed the appropriate amendments to DORA made. Poland, as well as several Member States, believes that NIS2 should be the main cybersecurity framework and any sectoral legislation should be aligned with the NIS2 provisions."

Statement by the Commission

"The Commission considers that Union submissions to be sent to the IMO are covered by EU exclusive competence. Submission of proposals to the IMO on issues of EU competence is an act of external representation, which, in accordance with Article 17(1) TEU, is the institutional prerogative of the Commission.

In the Commission's view, the procedural arguments against presenting submissions to the IMO by the Commission on behalf of the EU are not convincing. This is because there is no evidence to suggest that the IMO, as a specialised agency of the United Nations, would be in a position to reject such a submission.

The Treaty provisions on external representation of the Union must be applied. It should therefore be made by the European Commission on behalf of the European Union and sent to the IMO by the Commission.
