THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Article 305 thereof,

Having regard to Council Decision (EU) 2019/852 of 21 May 2019 determining the composition of the Committee of the Regions¹,

Having regard to the proposals of the Dutch Government,

Whereas:

- Pursuant to Article 300(3) of the Treaty, the Committee of the Regions is to consist of representatives of regional and local bodies who either hold a regional or local authority electoral mandate or are politically accountable to an elected assembly.
- On 10 December 2019, the Council adopted Decision (EU) 2019/2157¹, appointing the members and alternate members of the Committee of the Regions for the period from 26 January 2020 to 25 January 2025. On 24 April 2020 the Council adopted Decision (EU) 2020/577² appointing two alternate members, proposed by the Kingdom of the Netherlands, of the Committee of the Regions. On 29 April 2021 the Council adopted Decision (EU) 2021/721³ appointing a member and an alternate member, proposed by the Kingdom of the Netherlands, of the Committee of the Regions. On 20 December 2021 the Council adopted Decision (EU) 2021/2294⁴ appointing a member and an alternate member, proposed by the Kingdom of the Netherlands, of the Committee of the Regions. On 20 June 2022, the Council adopted Decision (EU) 2022/1001⁵, appointing a member, proposed by the Kingdom of the Netherlands, of the Committee of the Regions.
- (3) Five members' seats on the Committee of the Regions have become vacant following the end of the national mandates on the basis of which Mr Johan HAMSTER, Mr Michiel Alexander RIJSBERMAN, Mr Tjisse STELPSTRA, Mr Yde Johan VAN HIJUM and Ms Ilse ZAAL were proposed for appointment.
