

Subject: Temporary reintroduction of border control at internal borders in Poland

Dear Secretary - General,

In accordance with Article 23(1) and Article 24 of the Regulation (EC) No 562/2006 establishing a Community Code on the rules governing the movement of persons across borders (Schengen Borders Code) the Polish Government decided to reintroduce border control at its internal borders with respect to the forthcoming 19th session of the Conference of the Parties to the UN Framework Convention on Climate Change (UNFCCC) and the 9th session of the Conference of the Parties serving as the Meeting of the Parties to the Kyoto Protocol and the 39th Session of the Subsidiary Bodies which will take place in Warsaw from 11 to 22 November 2013.

Border control will be reintroduced for the period of 8 - 23 November 2013 at the Polish air, sea and land borders with the Federal Republic of Germany, the Czech Republic, the Slovak Republic, and the Republic of Lithuania. The scope and intensity of border control will be limited to the necessary steps to ensure public order and internal security. Crossing of the Internal borders of the Republic of Poland will be allowed in the authorized crossing-points which are enlisted in the attachment.

Please find attached a letter from the Minister of Interior concerning this issue.

Increased security requirements on the occasion of the 19th session of the Conference of the Parties to the UN Framework Convention on Climate Change (UNFCCC) and the 9th session of the Conference of the Parties serving as the Meeting of the Parties to the Kyoto Protocol and the 39th Session of the Subsidiary Bodies which will take place from 11 to 22 November 2013, have led me to reintroduce border control at the internal borders of the Republic of Poland, pursuant to Article 23 (1) and in accordance with Article 24 of *Regulation (EC) No 562/2006 of the European Parliament and of the Council* of 15 March 2006 establishing a Community Code on the rules governing the movement of persons across borders (the Schengen Borders Code), with a view to preventing entry into Poland of persons who may pose a serious threat to the public policy or internal security.

Border control will be restored for the period of 8 - 23 November, 2013 at the Polish air, sea and land border with the Federal Republic of Germany, the Czech Republic, the Slovak Republic, and the Republic of Lithuania. The scope and intensity of border control will be limited to the necessary steps to ensure public order and internal security. Border checks will not be carried out continuously and in all the authorized crossing-points, but in a flexible manner as to time and place, depending on the risk analyzes.

Crossing of the internal border of the Republic of Poland will be allowed in the authorized crossing-points, enlisted in the attachment.

All Member States are kindly requested to provide any information which may be relevant to putting the abovementioned measures into effect.

W związku z koniecznością zapewnienia bezpieczeństwa podczas organizacji 19. Sesji Konferencji Stron Ramowej Konwencji Narodów Zjednoczonych w sprawie zmian klimatu (UNFCCC COP 19), 9. Sesji Konferencji Stron służącej jako spotkanie Stron Protokołu z Kioto (CMP 9) oraz 39. Sesji Organów Pomocniczych, które odbędą się w dniach 11-22 listopada 2013 r., zgodnie z art. 23 ust. 1, w trybie art. 24 rozporządzenia (WE) nr 562/2006 Parlamentu Europejskiego i Rady z dnia 15 marca 2006 r. ustanawiającego wspólnotowy kodeks zasad regulujących przepływ osób przez granice (kodeks graniczny Schengen), mając na celu przeciwdziałanie wjazdowi do Polski osób, które mogą stanowić poważne zagrożenie dla utrzymania porządku publicznego i bezpieczeństwa wewnętrznego, podjąłem decyzję o wprowadzeniu tymczasowego przywrócenia kontroli granicznej na granicach wewnętrznych.

Kontrola graniczna zostanie przywrócona w okresie 8 - 23 listopada 2013 r. na odcinkach granicy państwowej z Republiką Czeską, Republiką Słowacką, Republiką Federalną Niemiec, Republiką Litewską oraz w morskich i lotniczych przejściach granicznych.

Zakres i intensywność kontroli granicznych zostaną ograniczone do niezbędnych czynności w celu zapewnienia porządku publicznego i bezpieczeństwa wewnętrznego. Kontrole graniczne będą realizowane na podstawie analizy ryzyka, w sposób elastyczny w odniesieniu do miejsca i czasu.

Przekraczanie wewnętrznej granicy Polski będzie dozwolone w wyznaczonych miejscach, zgodnie z listą zamieszczoną w załączniku.

Wszystkie państwa członkowskie proszone są o przekazywanie wszelkich niezbędnych informacji, celem wdrożenia ww. działań.
