

#### Statement by Italy and Romania

"L'Italia e la Romania sostengono la necessità di preservare la salute pubblica e concorda sulla necessità di intraprendere azioni adeguate a prevenire i rischi legati al fumo, sostenendo l'obiettivo di proteggere la popolazione dell'Unione Europea dal fumo passivo.

Tuttavia, desideriamo sottolineare che la procedura applicata per la discussione e l'approvazione da parte del Consiglio di questo Atto avrebbe necessitato di tempi e modalità migliori per lo svolgimento del dibattito tra gli Stati membri.

Allo stesso modo, si esprime rammarico per come molti commenti ed emendamenti significativi proposti dagli Stati membri non siano stati adeguatamente considerati e inclusi nel testo, in considerazione di un atto che, per la sua stessa natura e portata, avrebbe dovuto essere discusso e finalizzato al raggiungimento di un consenso tra le parti, tenendo adeguatamente in considerazione le preoccupazioni e le priorità nazionali chiaramente espresse dagli Stati membri. In termini politici, le posizioni basate sul consenso sono sempre la strada più adeguata.

Inoltre, come più volte ribadito, ci rammarichiamo per la mancata presentazione di un'adeguata valutazione d'impatto relativa a quest'atto, come base per la corretta valutazione da parte del Consiglio delle raccomandazioni proposte.

Tenendo conto di quanto sopra, esprimiamo la nostra speranza che le future discussioni all'interno del Consiglio, su questo argomento, terranno conto, più approfonditamente, di tutte le questioni sollevate dagli Stati membri.

Per quanto riguarda la valutazione degli aspetti sostanziali delle raccomandazioni incluse nell'Atto, si sottolinea che le misure generalizzate sui prodotti che emettono aerosol in determinate aree esterne, con specifico riferimento agli esercizi di servizio e ai luoghi di lavoro, mancano di una solida base scientifica e di un'adeguata valutazione d'impatto, e di conseguenza non avrebbero dovuto essere incluse nell'Atto.

Allo stesso modo, l'introduzione di raccomandazioni riguardanti misure ampie e generalizzate riferite alle aree esterne, non chiaramente identificate e associate a concetti come la presenza di traffico pedonale intenso, manca di fondamento giuridico e genera potenziale incertezza sul suo significato e sulla sua corretta attuazione, e di conseguenza non avrebbe dovuto essere inclusa nell'Atto.

Si ricorda infine che da questo Atto adottato dal Consiglio, per sua stessa natura e portata, non deriva alcun obbligo legale per gli Stati membri di definire adeguatamente la propria legislazione nazionale, tenendo conto delle competenze e delle specificità nazionali nell'attuazione, e non viene creato alcun precedente normativo per qualsiasi futura discussione in seno al Consiglio sulla politica europea del tabacco.

Per questo motivo, l'Italia e la Romania mantengono la propria preoccupazione politica sull'adeguatezza di alcune raccomandazioni, come sopra rappresentato, così come ogni ulteriore valutazione, in quanto Stato membro, sulla corretta attuazione nazionale di questo Atto."

#### Courtesy translation

"We support the need to preserve public health and agree on the need to take proper action for the prevention of smoke-related damages, supporting the objective of protecting people in the European Union from second-hand smoke.

Nevertheless, we wish to underline that the procedure applied for the discussion and approval by the Council of this Act would have needed a better timing and modalities of carrying out the debates among Member States.

Similarly, we regret that many significant comments and amendments proposed by the Member States have not been properly considered and included within the text, having regard to an Act that, for its own nature and scope, should have been discussed and finalized in order to reach consensus among Member States, properly taking into consideration national concerns and priorities as clearly expressed by Member States. In political terms, positions based on consensus are always the most suitable way ahead.

Moreover, as repeatedly stated, we regret the lack of any proper impact assessment presented on this Act, as a basis for the correct evaluation by the Council of the recommendations proposed.

Taking into consideration the above, we express our hope that future discussions within the Council, on this topic, will take into account, more thoroughly, all the issues raised by the Member States.

Regarding the assessment on the substantive aspects of the recommendations as included in the Act, we would like to underline that in our view generalized measures on aerosol-emitting products in certain outdoor areas, specifically referring to service establishments and workplaces, lack solid scientific ground and proper impact assessment, and consequently should not have been included in the Act.

Similarly, the introduction of recommendations regarding wide and generalized measures referring to outdoor areas, not clearly identified, and associated to concepts like the presence of heavy foot traffic, lacks of juridical ground and generates potential uncertainty about its proper meaning and correct implementation, and consequently should not have been included in the Act.

We remind that from this Act as adopted by the Council, for its own nature and scope, no legal obligation arises for Member States in properly defining their own domestic legislation, having regard to the national competencies and specificities in implementation, and no regulatory precedent is set for any future discussion within the Council regarding European tobacco policy.

That is why we do preserve our political concern on the appropriateness of certain recommendations, as represented above, and we do preserve any further evaluation as Member State on the proper national implementation of this Act."


