DOCUMENT PARTIALLY ACCESSIBLE TO THE PUBLIC (19.03.2024)

A. CONTEXT

1. The EU's Global Gateway Strategy includes hundreds of sustainable and quality investment projects that, in close cooperation with our partners, the EU and its Member States develop and invest in. Projects identified as flagships and included in the annual list are prominent examples of the progress and deliverables of Global Gateway. The aim of the annual list of flagship projects is to showcase the priorities of the Union, its Member States, and our partners, and contribute to strengthening our strategic partnerships and the promotion of our joint interests. The annual list of flagship projects supports the EU and its Member States in the promotion of projects in a coordinated, streamlined and targeted manner. The annual flagship list is not exhaustive in relation to all projects and activities under Global Gateway.

RELEX 1

The inclusion of projects from Member States in the flagship list does not guarantee EU financing for those projects.

- 2. The aim of the flagship list is to serve the EU and its Member States in their communication around Global Gateway, permitting them to foster concrete transformative projects and emphasize their tangible impact and benefits to local communities, for example during political events with our partner countries or during on-site visits. The identification of the yearly flagship list by the Relex Counsellors Horizontal Questions Working Party (hereinafter Relex HQ) singles out the relevant EU investment offer to our partners across the globe with flagship projects which are scheduled to deliver tangible results (milestones) during the specific year, in their respective Global Gateway key areas of partnership, as well as in the countries and regions concerned.
- 3. The yearly flagship list preparation is carried out in line with the Global Gateway governance (ST 13888/22 REV 1) with the input from the Commission, the EEAS and the Member States taking into account the criteria for identifying flagships (ST 10532/22) and the political priorities identified both by the EU, its Member States and our partners. The first flagship list for 2023 (ST 6738/23) was prepared by Relex HQ and endorsed by COREPER on 1 March 2023.
- 4. To maximize the impact of communication on Global Gateway by the EU and its Member States and the diversity of EU's offer to partners, annual lists of flagship projects should not overlap. Once a project is included in the flagship list, it remains a flagship project, and therefore a priority for communication until the end of the cycle of the project concerned irrespective of the duration of the project. Project implementation and delivering on milestones, which are updated annually and regularly as needed, remain priorities of the overall Global Gateway implementation and together with consistent communication are key to EU's credibility. To follow up and keep track on the implementation of the flagship projects, the Commission will use the Global Gateway Platform. Member States in the lead of Flagship project implementation are encouraged to do the same.

B. LIST OF GLOBAL GATEWAY FLAGSHIP PROJECTS FOR 2024

- 5. The Commission put forward a draft proposal for a list of Global Gateway flagship projects for 2024 (WK 13135/2023 INIT) on 12 October 2023.
- The Relex HQ has discussed the proposal at its meetings on 13 October 2023, 24 October 2023 and 10 November 2023.
- On the basis of the discussions in Relex HQ, and the written contributions provided by Member States, the Presidency had put forward several revised proposals: WK 13135/2023 REV 1, 13135/2023 REV 2, 13135/2023 REV 3 and 13135/2023 REV 4.
- 8. Agreement on the list was reached on 20 November 2023.
- 9. References to geographical regions and references to Master Table have been streamlined.
- In line with the Global Gateway Governance defined in document ST 13888/22 REV1, COREPER is therefore invited to endorse the list of Global Gateway flagship projects for 2024 in the annex.
