Confirmation of the final compromise text with a view to agreement

<u>The SCA</u> noted the existence of a qualified majority to approve the text as set out in document 14767/24.

The SCA therefore authorised the Presidency to send a letter to the European Parliament informing it that a first reading agreement could be reached on the Commission's proposal, provided that Parliament agreed to adopt its position in the form of that text.

<u>The Presidency</u> informed the SCA about the next SCA meeting on 3 December 2024 and the "Agriculture and Fisheries" Council meeting on 18 November 2024.

Regarding that Council meeting,

- <u>Spain</u> requested a public item under "any other business", on the "the implementation of the N+3 rule, instead of the N+2 initially foreseen, for rural development interventions in the CAP Strategic Plans";
- <u>Lithuania</u> requested a public item under "any other business", on "the flexibility of reimbursement of costs under EARFD";
- <u>Bulgaria</u> requested a public item under "any other business", on "Protective measures under Article 4(1) of Regulation (EU) 2024/1392 for imports of Ukrainian honey into Bulgaria";
- <u>The SCA</u> agreed that these three AOB items would be taken in public session in accordance with Article 8(2) of the rules of procedure of the Council.
- <u>The Presidency</u> informed the SCA that they would include an item under "any other business", on "Presidency summary of the discussions on the challenges and future perspectives of the different agricultural sectors".
