#### 7. Organisation of future work

The Presidency informed the SCA about the "Agriculture and Fisheries" Council meeting on 20 November 2023.

As regards that Council meeting,

- the Italian delegation requested an item under "any other business" on the Role of farmers in ensuring sustainability in rural areas, to be held in public session;
- the French delegation requested an item under "any other business" on a partial application of Good Agricultural and Environmental Condition (GAEC) no. 8 for the 2024 campaign; to be held in public session.
- The SCA subsequently agreed that these two items would be held in public session in accordance with article 8(2) of the rules of procedure of the Council.
- Futhermore, the German delegation informed the SCA about an item under "any other business" on support measures for partner countries within the EU Regulation on deforestation-free supply chains, which would be requested at COREPER.

The Presidency also informed the SCA that the December "Agriculture and Fisheries" Council meeting would take place on Sunday 10 and Monday 11 December.
