The SCA took note:

- of the scrutiny reserves entered by delegations;
- of the comments made by the Commission representative.

The Presidency set a silent deadline of Wednesday 12 October 2011, 12.00 by which it would be presumed that delegations would have lifted their scrutiny reserves unless the Secretariat had been notified otherwise. This would thus give the Presidency the appropriate negotiating mandate with a view to the first informal trilogue on the basis of the four column document (doc 15139/11), bearing in mind at this stage that all the issues relating to the horizontal approach on the alignment of the agricultural legislation with the Lisbon Treaty were subject to a parallel discussion.

The SCA took note

- that an agreement could not be reached at this meeting on a draft Council Decision establishing a Union position, given that a large number of delegations still had reserves on the procedure proposed;
- of the Presidency's request made to the Council Legal Service to deliver a written opinion on the use of Article 218(9) TFEU as the legal basis for the proposed procedure;
- of the views of the Council Legal Service on the consequences of not having a position defined in Council;
- that the item would be put on the agenda of the next Council meeting on 20 -21 October 2011, as a "B" point.
