Suġġett: Test kongunt dwar il-baġit ġenerali tal-Unjoni Ewropea għas-sena  
finanzjarja 2026 Approvazzjoni

---

1. Wara l-laqgħat tal-Kumitat ta' Konċiljazzjoni fl-4, l-14 u l-15 ta' Novembru 2025, intlaħaq qbil bejn il-Parlament Ewropew u l-Kunsill dwar test kongunt kif previst fl-Artikolu 314(5) TFUE.
2. Dan it-test kongunt u l-annessi tiegħu ntbagħtu lill-Parlament Ewropew u lill-Kunsill fil-15 ta' Novembru 2025, u kull wieħed minnhom għandu perjodu ta' erbatax-il jum minn din il-ġurnata biex japprovah (ara l-ANNESS). It-test kongunt jikkonsisti mid-dokumenti li ġejjin meħudin flimkien, irregjistrati fl-Addenda 1 sa 5 ta' dan id-dokument:
  - ċifri sommarji skont l-intestaturi tal-qafas finanzjarju (ara d-dokument 15487/25 ADD 1);
  - ċifri linja b'linja għall-partiti tal-baġit kollha (ara d-dokumenti 15487/25 ADD 2 u ADD 3);
  - dokument ikkonsolidat li juri ċ-ċifri u t-test finali tal-linji kollha emendati matul il-Konċiljazzjoni (ara d-dokumenti 15487/25 ADD 4 u ADD 5).

Dear President,

Based on Article 314(4) and (5) of the Treaty on the Functioning of the European Union (TFEU), and following information by the Council that it could not accept all the amendments adopted by the European Parliament on 22 October 2025 on the Council's position on the draft budget for 2026<sup>1</sup>, the Conciliation Committee was convened for 28 October 2025, with a view to reaching agreement on a joint text.

The Conciliation Committee had at its disposal the following elements:

- draft budget proposed by the Commission (COM(2025) 300 final of 9 July 2025), as amended by letter of amendment No 1 (COM(2025) 851 final of 9 October 2025);
- Council's position on the draft budget (5 September 2025);
- European Parliament's amendments to the Council's position (22 October 2025).

Following meetings on 4, 14 and 15 November 2025 an agreement has been reached on 15 November 2025 on a joint text as provided for in Article 314(5) TFEU.

In accordance with Point 24 of Annex 1 to the Interinstitutional Agreement of 16 December 2020<sup>1</sup>, the joint text for the budget 2026 shall consist of this letter and the following documents taken together, which are recorded in Annex 1:

- line by line figures for all budget items and summary figures by MFF headings;
- a consolidated document, indicating the figures and final text of all lines that have been amended during the conciliation procedure;
- the list of the lines not amended with regard to the draft budget or the Council's position on it.

Pursuant to Article 314(6) TFEU, the joint text is hereby forwarded to the European Parliament and the Council, which shall each have a period of fourteen days from this day, in which to approve the text for the purposes of paragraphs 7 and 8 of the same Article.

The Conciliation Committee has also agreed on or taken note of the statements recorded in Annex 2 to this letter.

An identical letter is addressed to the President of the European Parliament.

**DIKJARAZZJONIJIET**

**1. Dikjarazzjoni kongunta mill-Parlament Ewropew u l-Kunsill dwar l-appropriazzjonijiet ta' pagament**

Il-Kunsill u l-Parlament Ewropew jappellaw lill-Kummissjoni tibqa' timmonitorja mill-qrib u b'mod attiv matul is-sena 2026 l-implementazzjoni tal-programmi (b'mod partikolari dawk taht is-subintestatura 2a u tal-Iżvilupp Rurali). Għal dan il-għan, il-Parlament Ewropew u l-Kunsill jistiednu lill-Kummissjoni tippreżenta, fi żmien debit, cifri aġġornati li jikkonċernaw is-sitwazzjoni attwali u l-istimi rigward l-appropriazzjonijiet ta' pagament għall-2026.

Jekk iċ-cifri juru li l-appropriazzjonijiet imdaħhla fil-baġit għall-2026 mhumiex biżżejjed biex ikopru l-htigijiet ġustifikati, il-Parlament Ewropew u l-Kunsill jistiednu lill-Kummissjoni tippreżenta mill-aktar fis possibbli soluzzjoni xierqa, fost l-oħrajn, abbozz ta' baġit emendatorju, bil-hsieb li l-Parlament Ewropew u l-Kunsill ikunu jistgħu jiehdu kwalunkwe deċiżjoni meħtieġa malajr kemm jista' jkun minghajr dewmien żejjed għal htigijiet ġustifikati. Fejn applikabbli, il-Parlament Ewropew u l-Kunsill ser iqisu l-urgenza tal-kwistjoni, billi jnaqqsu l-perjodu ta' tmien ġimgħat għal deċiżjoni jekk jitqies meħtieġ. L-istess japplika mutatis mutandis jekk iċ-cifri juru li l-appropriazzjonijiet li ddaħhlu fil-baġit għall-2026 ikunu oġhla minn kemm ikun meħtieġ.

**2. Dikjarazzjoni unilaterali tal-Kummissjoni dwar l-aġenziji**

Sabiex jiġi żgurat li l-aġenziji jwettqu l-mandati tagħhom bl-aktar mod kosteffiċjenti, il-Kummissjoni tirrikonoxxi l-htieġa li tkompli tkun estremament viġilanti meta tivvaluta l-htigijiet baġitarji tal-aġenziji, filwaqt li tirsisti biex jintlaħqu l-effiċjenzi u r-razzjonalizzazzjonijiet.
