1. Cumulatieve gegevens voor de huidige programmeringsperiode (3 mei 2021 – 31 december 2024)

De gegevens in de grafieken 1 tot en met 8 en de tabellen 1 tot en met 4 hebben betrekking op aanvragen die tussen 3 mei 2021¹ en 31 december 2024 door de lidstaten zijn ingediend in het kader van Verordening (EU) 2021/691 van het Europees Parlement en de Raad van 28 april 2021 betreffende het Europees fonds voor aanpassing aan de globalisering voor ontslagen werknemers en tot intrekking van Verordening (EU) nr. 1309/2013 (EFG-verordening 2021-2027).

Tussen 2021 en 2024 heeft de Commissie 18 aanvragen ontvangen: zes betroffen ondernemingen in crisis, vijf waren handelsgerelateerd en zeven betroffen verschillende redenen². Meer in het bijzonder hadden twaalf aanvragen betrekking op ontslagen bij een onderneming³, vier hadden betrekking op ontslagen in dezelfde sector en regio⁴, een had betrekking op ontslagen in een regio⁵ en een had betrekking op ontslagen op een kleine arbeidsmarkt⁶. Het totale aangevraagde EFG-bedrag bedroeg 60 188 105 EUR en het beoogde aantal begunstigden was 10 825⁷.

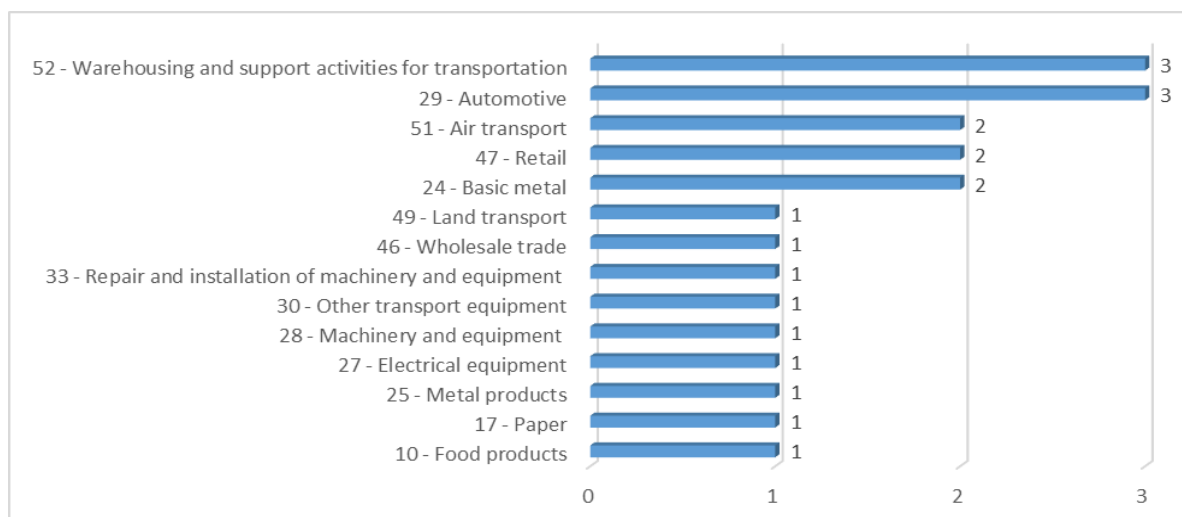

* Drie aanvragen hebben betrekking op meer dan één sector en zijn daarom meerdere keren meegeteld.

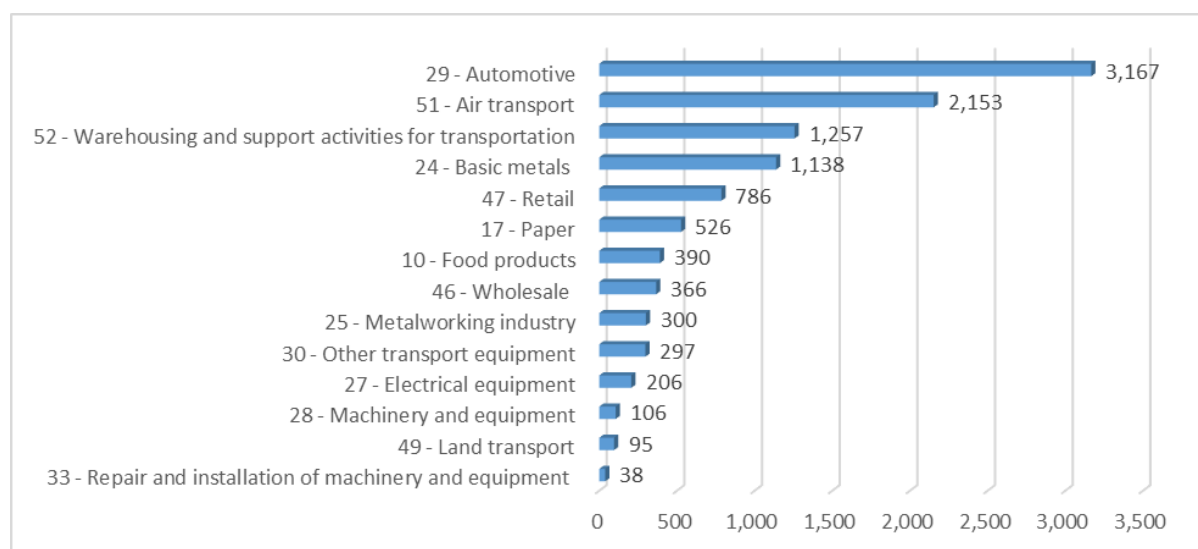

Tussen 2021 en 2024 heeft de Commissie 18 EFG-aanvragen ontvangen van 7 lidstaten, waarin werd voorgesteld om 10 825 werknemers in 14 verschillende sectoren te ondersteunen. De automobielsector en opslag en vervoerondersteunende activiteiten waren goed voor het hoogste aantal aanvragen (elk drie aanvragen).

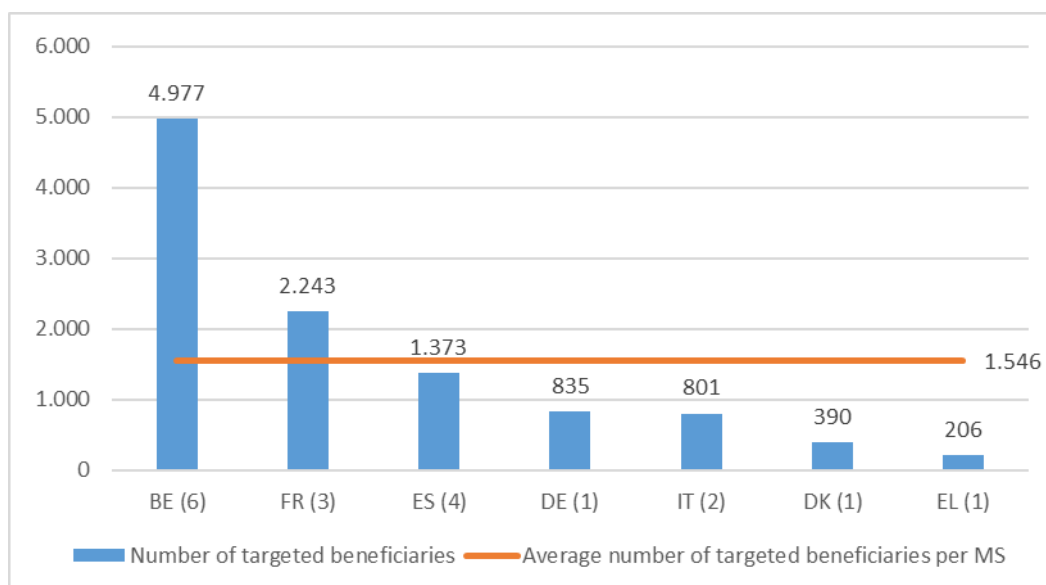
Het grootste aantal beoogde begunstigden was in de automobielsector (3 167 in drie aanvragen), gevolgd door luchtvervoer (2 152 in twee aanvragen). In twee sectoren, opslag en vervoerondersteunende activiteiten (drie aanvragen) en metalen in primaire vorm (twee aanvragen), waren er meer dan 1 000 beoogde begunstigden. De drie sectoren met het laagste aantal beoogde begunstigden (tot 100) waren gekoppeld aan aanvragen waarin verschillende sectoren werden gecombineerd.

Grafiek 3: Aantal beoogde begunstigen per lidstaat, 2021-2024

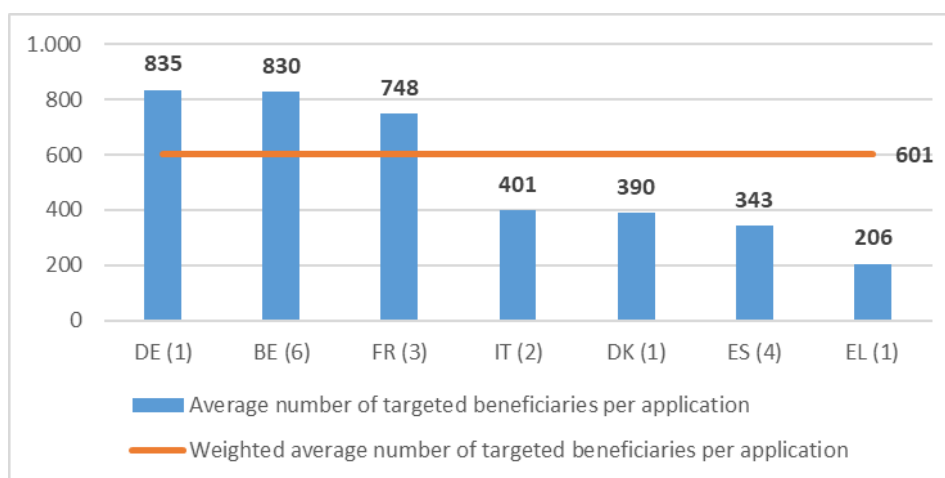

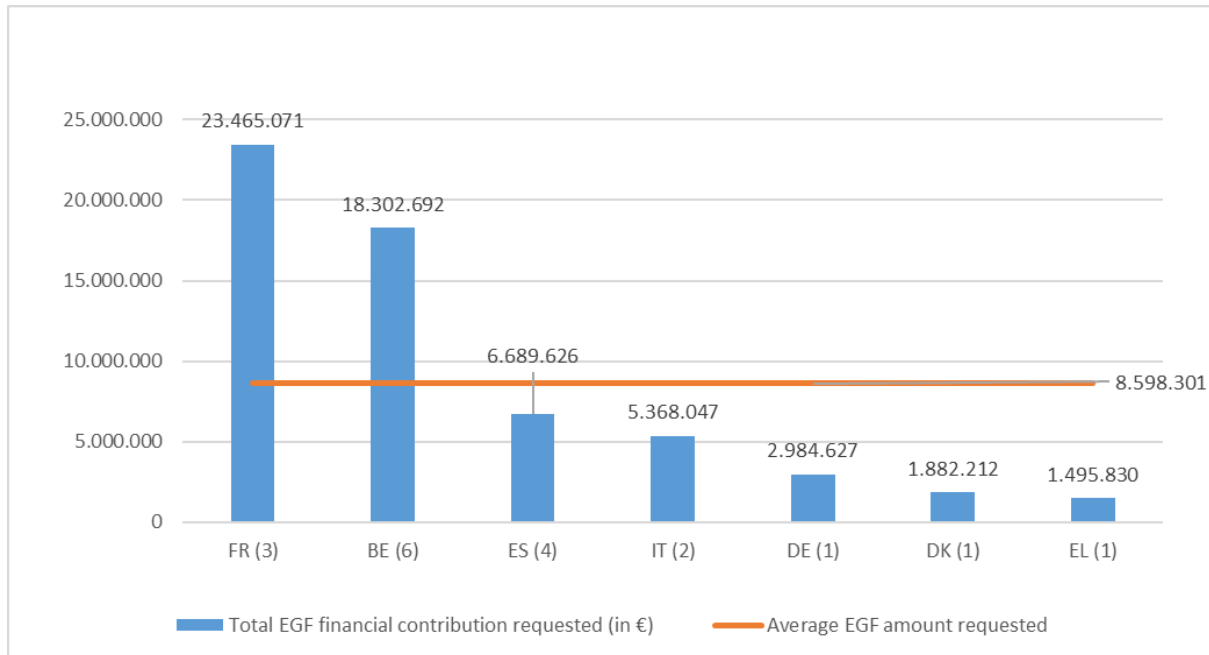
In de tussen 2021 en 2024 ingediende aanvragen werd voorgesteld om in totaal 10 825 begunstigen te ondersteunen. België heeft steun aangevraagd voor het hoogste aantal werknemers (4 977 in vijf aanvragen), gevolgd door Frankrijk (2 243 in drie aanvragen) en Spanje (1 373 in vier aanvragen). Wat het gemiddelde aantal beoogde begunstigen per aanvraag betreft, stelden Duitsland en België voor het grootste aantal werknemers te ondersteunen (elk ongeveer 830), gevolgd door Frankrijk (748).

Grafiek 5: EFG-bedrag (in EUR) dat elke lidstaat heeft aangevraagd, 2021-2024



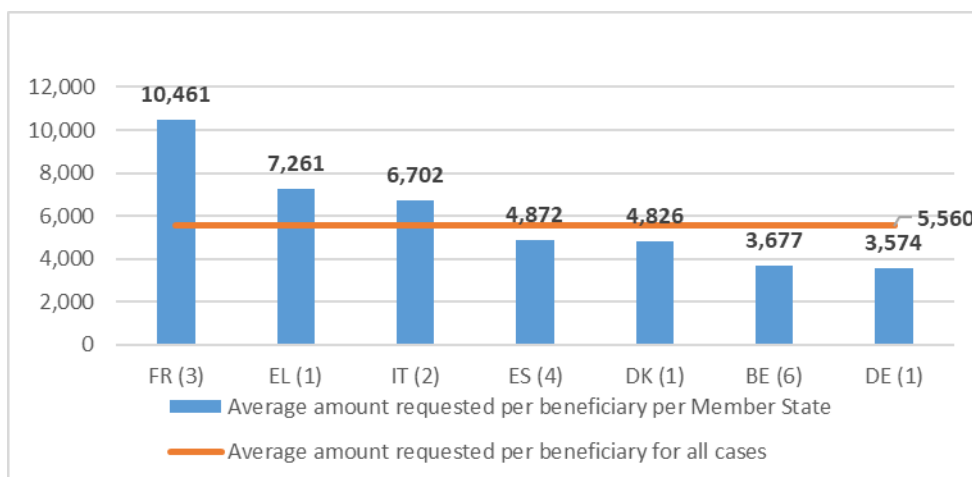

Tussen 2021 en 2024 hebben zeven lidstaten een totaalbedrag uit het EFG aangevraagd van 60 188 105 EUR. Frankrijk heeft het hoogste bedrag (23 465 071 EUR voor drie aanvragen) aangevraagd, gevolgd door België (18 302 692 EUR voor zes aanvragen) en Spanje (6 689 626 EUR voor vier aanvragen). Tabel 1 bevat nadere gegevens over de aanvragen per jaar en per lidstaat.

Gemiddeld heeft elke lidstaat 5 560 EUR per beoogde begunstigde aangevraagd. Frankrijk heeft het hoogste gemiddelde bedrag per beoogde begunstigde aangevraagd (10 461 EUR), gevolgd door Griekenland (7 261 EUR) en Italië (6 702 EUR).

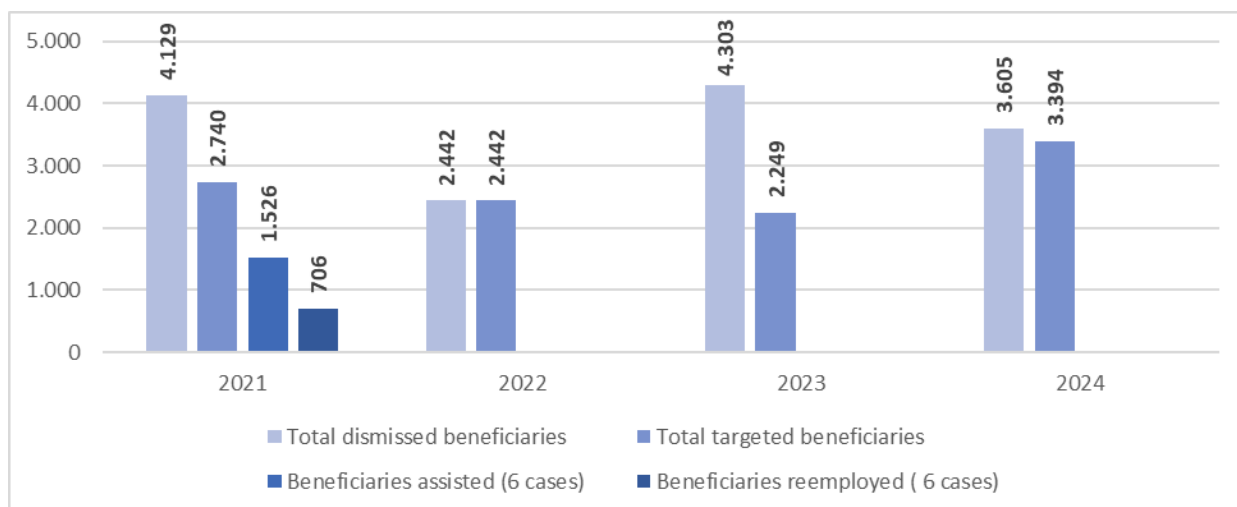
De eindverslagen moeten ongeveer drie jaar na de datum van de aanvraag worden ingediend. Eind 2024 waren slechts zes eindverslagen ingediend voor aanvragen die in de eerste helft van 2021 waren ontvangen.

Het gemiddelde re-integratiepercentage (46 %) ligt 5 procentpunten lager dan het gemiddelde percentage voor dossiers in 2007-2020 (51 % voor 164 dossiers, zie tabel 8). Dit cijfer moet echter met de nodige voorzichtigheid worden gezien, aangezien het gebaseerd is op beperkte gegevens.

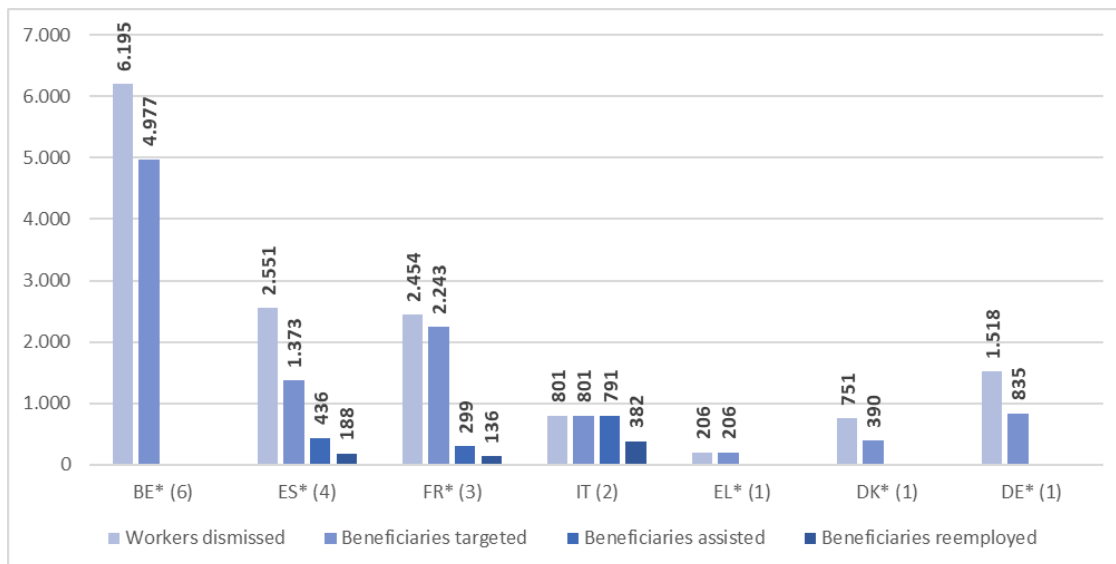

2. Cumulatieve gegevens voor 2007-2020

Tussen 2007 en 2020 heeft de Commissie 165 aanvragen ontvangen, waarvan 85 crisisgerelateerde en 80 handelsgerelateerde aanvragen. Uitgesplitst naar criteria voor steunverlening had 47 % betrekking op ondernemingen, 39 % op dossiers in dezelfde regio en sector en 14 % op uitzonderlijke omstandigheden. Het aantal ontvangen aanvragen per jaar varieerde aanzienlijk (van nul tot 27, met een gemiddelde van ongeveer 12), wat een weerspiegeling was van economische turbulenties zoals de economische en financiële crisis of de pandemie.

Van 2007 tot 2013 werd 112 keer middelen uit het EFG beschikbaar gesteld voor een totaalbedrag van 478,6 miljoen EUR (gemiddeld 4,7 miljoen EUR per dossier) om steun te bieden aan 105 030 werknemers (gemiddeld 938 personen per dossier).

Ter vergelijking: tussen 2014 en 2020 waren er 53 beschikbaarstellingen voor een totaalbedrag van 168,7 miljoen EUR (3,2 miljoen EUR per dossier) ter ondersteuning van 56 807 werknemers (1 072 personen per dossier). Dit is ongeveer de helft van de beschikbaarstellingen in de periode 2007-2013, toen het aantal aanvragen aanzienlijk toenam als gevolg van de economische en financiële crisis. Anderzijds lag het gemiddelde aantal beoogde begunstigden per dossier 14 % hoger dan in 2007-2013.

Hoewel het EFG in de periode 2007-2013 werknemers uit 49 economische sectoren heeft ondersteund, waren drie sectoren goed voor de helft van de 105 030 betrokken werknemers: de

automobielsector⁸ (22 903), elektronica⁹ (18 148) en textielproducten¹⁰ (11 504). In de periode 2014-2020 maakte de helft van degenen die steun kregen deel uit van vijf sectoren: de automobielsector, met het hoogste aantal beoogde begunstigden (10 299), detailhandel¹¹ (6 536), wegvervoer¹² (4 645), machinebouw¹³ (4 003) en elektronica (3 115).

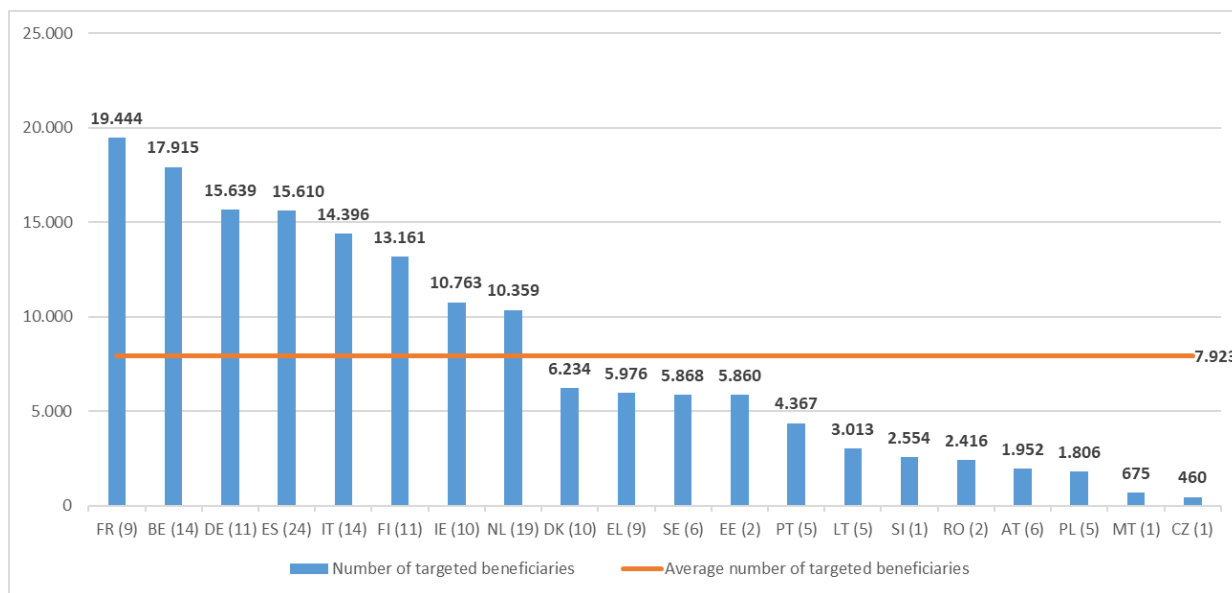

Grafiek 9: Aantal beoogde begunstigen per lidstaat, 2007-2020

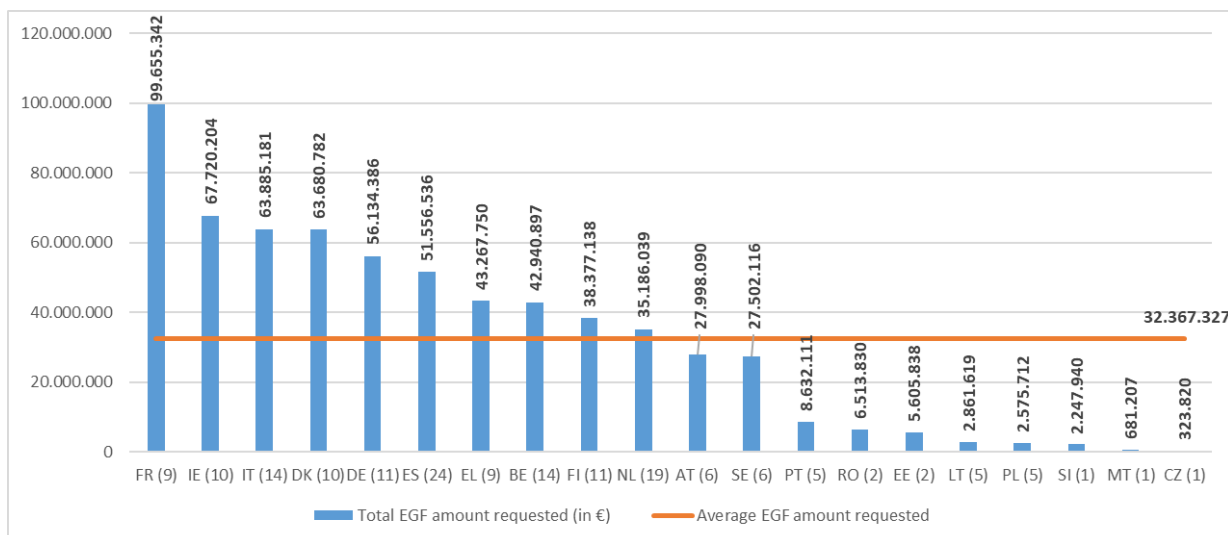

Tussen 2007 en 2020 werden 165 aanvragen ingediend (met uitzondering van de ingetrokken of afgewezen aanvragen) door twintig lidstaten, waarbij werd voorgesteld 158 468 werknemers en 3 369 personen die geen werk hebben en geen onderwijs of een opleiding volgen (NEET's), te ondersteunen. Frankrijk heeft steun aangevraagd voor het hoogste aantal begunstigen (19 444 voor 9 dossiers), gevolgd door België (17 915 voor 14 dossiers) en Duitsland (15 639 voor 11 dossiers). Het totaalbedrag aan medefinanciering uit het EFG dat werd aangevraagd, was 647 346 538 EUR. Frankrijk heeft het hoogste bedrag (99 655 342 EUR voor 9 aanvragen) aangevraagd, gevolgd door Ierland (67 720 204 EUR voor 10 aanvragen) en Italië (63 885 181 EUR voor 14 aanvragen).

Grafiek 10: EFG-bedrag (in EUR) dat elke lidstaat heeft aangevraagd, 2007-2020

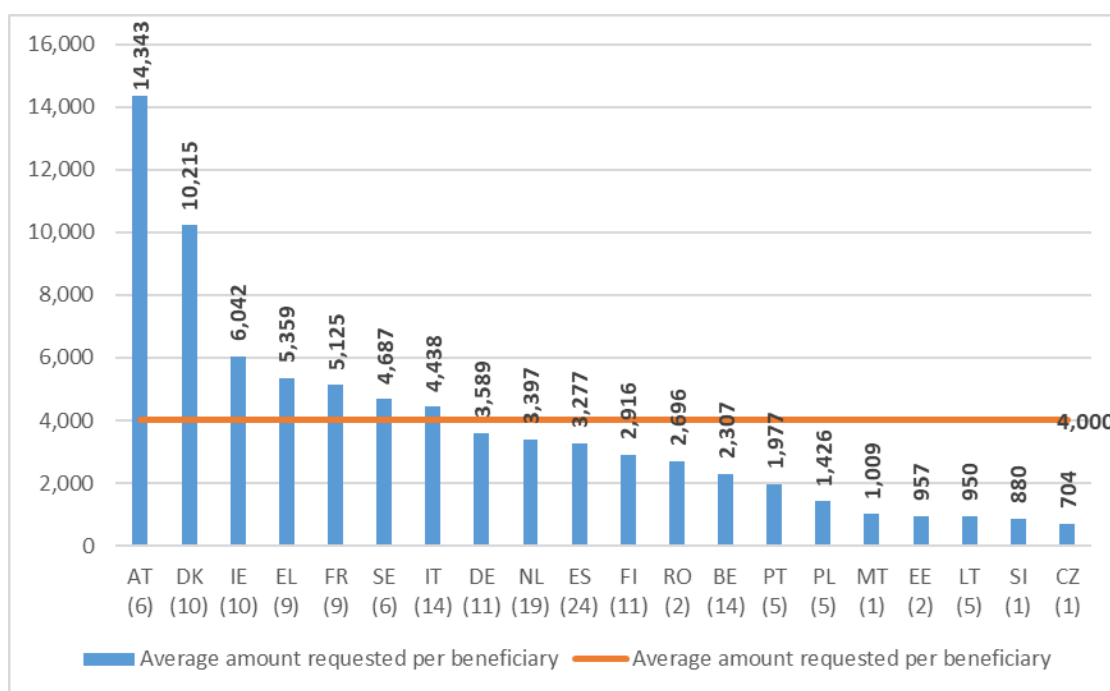

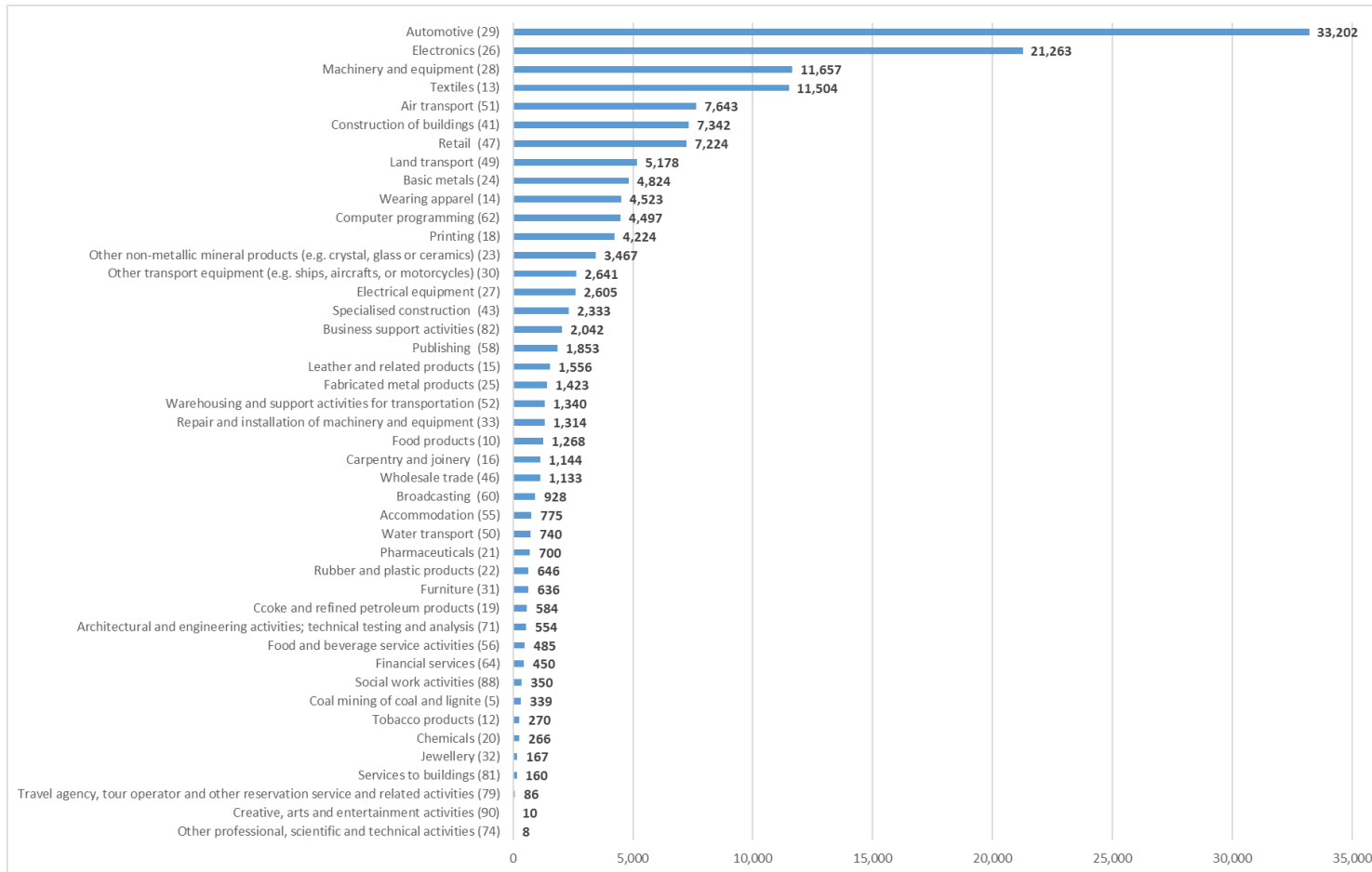

De tussen 2007 en 2020 ingediende aanvragen hadden betrekking op ontslagen werknemers in 48 sectoren. De aangeboden steun is het grootst in de automobielsector (33 202 werknemers, 23 aanvragen), gevolgd door de sector computers en elektronica (21 263 werknemers, 17 dossiers), de sector machines en apparaten (11 657 werknemers, 15 dossiers) en de sector textielproducten (11 504 werknemers, 11 dossiers). Een op de drie werknemers die EFG-steun kregen aangeboden, behoorde tot een van deze vier sectoren.

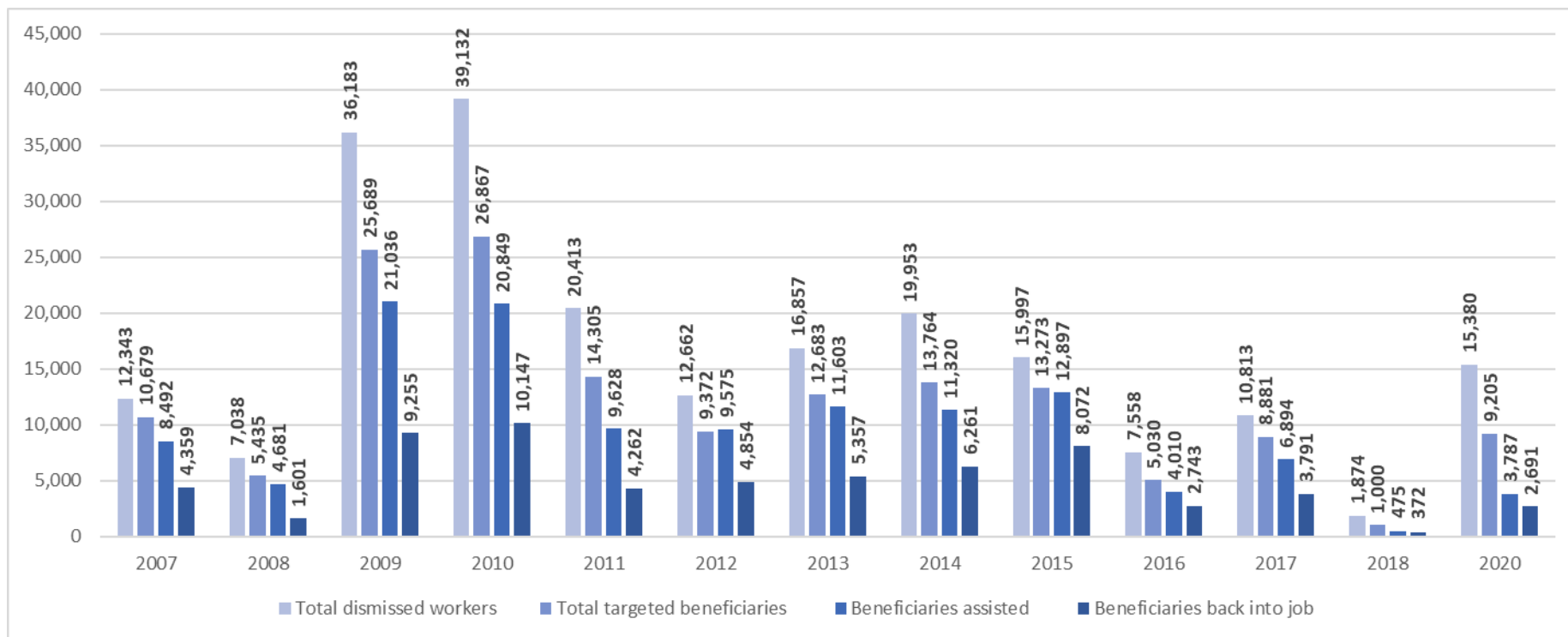
