Equivalence

On the issue of **equivalence of greening practices**, the <u>SCA</u> noted the Presidency's summary, the main elements of which were as follows:

- A <u>very large number of delegations</u>, while acknowledging that the Danish Presidency consolidated text went into the right direction, wanted to extend, adjust or further specify the equivalence concept, in particular on the basis of ensuring an equivalent level of additional benefits for the environment. <u>Some delegations</u> underlined the importance of ensuring the same level of benefits across the EU or were concerned about making fulfilment of greening too easy.
- Many delegations wanted to see a wider concept of equivalence being applied to the
 three proposed greening practices. Some found the concept useful in the context of
 certification schemes and others for qualifying farms in whole or in part as green by
 definition
- <u>Some delegations</u> suggested that *ipso facto* greening should, in addition to organic farmers, also apply to farmers implementing 2nd pillar Agri-Environment/C limate Measures (AECMs) on a significant proportion of their farmed land, as well as to farmers involved in sufficiently ambitious certification schemes.

- Some delegations wanted to better acknowledge the efforts made by farmers whose holdings are only partially subject to AECMs or other green by definition practices, or who have at least a certain percentage of their agricultural area situated in Natura 2000 zones or covered by forest, by exempting the respective areas from one or more of the proposed greening requirements.
- A <u>number of delegations</u>, while underlining that Member States' specificities should be taken into account, saw an important role for the Commission in rule-setting and validation with regard to equivalence. <u>Several delegations</u> agreed that national or regional certification schemes should be subject to *ex ante* validation by the Commission. <u>Others</u> suggested that AECMs acceptable for equivalence purposes could be validated by the Commission when approving Member States' rural development programmes. <u>Several delegations</u> underlined the need to avoid delays and overly complicated procedures.

The <u>SCA</u> also noted the delegations' other comments and the comments made by the <u>Commission representative</u>.

Baseline

On the issue of **baseline**, the <u>SCA</u> noted the Presidency's summary, the main elements of which were as follows:

- Many delegations still object to the inclusion of greening in the baseline for second pillar agri-environment and climate measures and do not consider that double funding would be a problem.
- Some delegations also noted that the approach should be consistent, and if greening is
 not included in the baseline for organic farming, Natura 2000 and the Water Framework
 Directive measures under the 2nd pillar, it should not be included in the baseline for
 agri-environment and climate measures either.

- A number of delegations stated that greening must be part of the **baseline** in order to ensure that commitments under the second pillar go beyond mandatory **greening** requirements. The Commission repeated that, from a legal point of view, double funding is not justifiable.
- Some delegations acknowledged that the concept of green by definition or green *ipso* facto as well as a broader definition of equivalence based on the same level of environmental benefit are steps in the right direction from the point of view of addressing the issue of the second pillar baseline.
- <u>Many delegations</u> stressed that there is need for further clarification on the equivalence of certain parts of the commitment under the 2nd pillar, with the greening requirement of the 1st pillar.

The <u>SCA</u> took note of delegations' views and of the <u>Commission's</u> reply.

7. Organisation of future work

The <u>Presidency</u> informed the <u>SCA</u> on the preparation of its next meeting on 5 November 2012.
