### Statement by the Czech Republic, Hungary and the Slovak Republic

"The Czech Republic, Hungary and the Slovak Republic support the aims of the Regulation, especially harmonising the rules for fertilising products.

Nevertheless, the Czech Republic, Hungary and the Slovak Republic regret the low ambition of the final compromise regarding the level of cadmium in phosphate fertilisers, which does not sufficiently recognize the hazards and risks cadmium carries. The limit of 60 mg cadmium/kg P<sub>2</sub>O<sub>5</sub> for phosphate fertilisers containing more than 5% P<sub>2</sub>O<sub>5</sub> cannot be deemed satisfying – especially when taking into account the need to strengthen the protection of human health and environment as it is the aim of the Regulation.

The Regulation should better address the risks for health and environment posed by the use of fertilisers containing high cadmium levels, which are apparent from the Commission's impact assessment and recent research in the field.

**Member States with current low national limits for cadmium content in fertilisers should be allowed to keep that limit also for the harmonised area until the EU limit reaches the same level. In this context the Czech Republic, Hungary and the Slovak Republic strongly believe that any Member States wishing to secure a higher level of protection of their soil will receive the opportunity provided by the Treaty.**

The cadmium content of fertilizers is to be reduced over the time and we request the Commission to do its utmost not to miss the opportunity during the revision of this Regulation.

As the Regulation fails to set a limit value for total chromium, being a highly toxic heavy metal, the Czech Republic, Hungary and the Slovak Republic still hold the view that the Commission should reconsider the labelling requirements for the total chromium content of fertilizing products. In this line, the information on the maximum quantity and on the exact source of chromium shall appear on the label of all the products concerned.

The final compromise text does not set clear guidelines for plant biostimulants considering requirements for evaluation of biological effectiveness, qualitative expectations and details of active substances that would be essential for such a heterogeneous group of products.

We maintain the opinion that adapting the Annexes to technical progress is equivalent to amending the legal content of the proposed legislation. Amendments to Annexes I and II for the purpose of adapting them to technical progress should be done by means of Implementing Acts."

## **Agriculture**

### 14. Regulation amending general food law 15148/18 + ADD 1 *Preparation for a general approach*

The Committee slightly revised the text and agreed to forward it to Council in view of a general approach.

#### Statement by the Netherlands

"The Netherlands supports the ambition for more transparency and the adjustment in the procedures in order to achieve more transparency and objectivity in the risk assessment in the Food Chain.

The proposed measures are useful to achieve these targets, such as the plan on risk communication as well as the Union register for the publication of the studies accompanying an approval for regulated products.

Nevertheless, The Netherlands wants to emphasize the importance of a level playing field for European food business operators regarding the development of innovative products. In some cases this needs additional attention, meaning that the obligation to disclose non-confidential studies immediately after having submitted a request for approval to EFSA may hinder instead of promote innovation.

Furthermore, it is important that the system to be set up with the Union register for the publication of studies, including procedures, is efficient and effective. The administrative burden should be kept to a minimum for the food business operators, for EFSA and for Member States.

The Netherlands supports the proposal of the Austrian Presidency to start the negotiation with the European Parliament and the Commission (trilogue).

The Netherlands would however like to stress that the general approach in no way pre-emptes or prejudices the negotiations on the MFF.

That means that an agreement to start negotiations with the EP does not in any way imply consent on the financial impact of the proposal as stated by the Commission in the Legislative Financial Statement which accompanied the legislative proposal of 11 April 2018.

Though NL recognizes that as a result of the present proposal a limited amount of additional means are necessary for EFSA to fulfill the new tasks, the Netherlands have strong doubts if the present proposal of € 62,5 million is realistic. It is almost a doubling of the present EFSA budget. Here the lack of an impact assessment has been felt strongly.

Moreover, and even more important the financial impact of the proposal of the Commission goes beyond the present MFF framework. The indicative ceilings for the EFSA can only be agreed upon once there is a final decision about the available budget for the MFF 2021-2027 in total, heading 7, the agencies and in particular the EFSA.

If the Parliament, Council and Commission could come to an agreement in the trilogues, all parties should take the financial impact of the proposal in reconsideration and have a clear and balanced position."

#### **Statement by the Commission**

"The Commission underlines that it is contrary to the letter and to the spirit of Regulation 182/2011 to invoke Article 5 § 4, subparagraph 2, point b) in a systematic manner. Recourse to this provision must respond to a specific need to depart from the rule of principle which is that the Commission may adopt a draft implementing act when no opinion is delivered. Given that it is an exception to the general rule established by Article 5 (4) recourse to subparagraph 2, point b), cannot be simply seen as a "discretionary power" of the legislator, but must be interpreted in a restrictive manner and thus must be justified.

While the Commission notes the agreement reached by the European Parliament and the Council on the recourse to this provision it regrets that such justification is not reflected in a recital."

### Statement by Greece

"Greece would like to thank the Presidency for its efforts to reach an agreement with the European Parliament, but, unfortunately, **cannot support the final compromise text and will vote against**. The outcome of the negotiations diverges significantly from the General Approach, which was already not acceptable to Greece, and does not take into account our concerns, which were consistently raised at all stages of the discussions on this file.

The reasons for Greece's position are, among others:

- The vagueness of the subject matter and the lack of clarity regarding certain important definitions (such as 'threat of injury', 'Union interest', 'irreversible damage') as well as regarding the proceedings, lead to legal uncertainty.
- The practices distorting competition are not explicitly mentioned and the operational redressive measures provided for in the proposal are not exhaustively listed, causing further ambiguity. In addition, there is no 'escalation' of these measures depending on the extent of the injury, and therefore no legal predictability, nor a link between a specific practice and the respective 'remedy'.

The Regulation may have a strong impact on bilateral relations of Member States with third parties, in the field of aviation; this is due, *inter alia*, to the apparent incompatibility of the proposed text with the dispute settlement provisions contained in bilateral air transport agreements. Thus, the implementation of the said Regulation may impede Member States from fulfilling their international obligations."

### **Statement by Germany, France, Belgium, Greece and Cyprus**

"Germany, France, Belgium, Greece and Cyprus are expressing their concerns with regard to the use of delegated acts (foreseen in articles 17 and 19) in order to develop the provisions for a monitoring and evaluation framework, including by reviewing or supplementing the indicators of Annex II.

These evaluation indicators are crucial for the further development of the programme. That's why Germany, France, Belgium, Greece and Cyprus consider that these indicators are to listed in the basic act and thus be adopted by the European legislator, i.e. the European Parliament and the Council, rather than by the European Commission by way of delegated acts."

### **Statement by Germany, Ireland and Italy**

"Germany, Ireland and Italy wholeheartedly welcome the decision to maintain the European funding programme Creative Europe, with its lines of funding for culture and audiovisual media, as an independent, visible programme through the period 2021 to 2027. Following negotiations in the Council working party and the debate in the meeting of the European ministers responsible for culture and media, we now have a strong foundation for our future work.

However, Germany, Ireland and Italy can only agree to the text with reservations, given that efforts to explicitly anchor the European Union Youth Orchestra in the draft sectoral regulation failed. Germany, Ireland and Italy will therefore approve the funding programme in the hope and expectation that a long-term, stable financial basis will continue to be provided for the European Youth Orchestra in the period 2021 to 2027.

The European Youth Orchestra is an outstanding institution that serves as a showpiece of European culture and an ambassador for the European project. The orchestra also represents transnational cooperation among young musicians. Germany, Ireland and Italy therefore regret the omission of a strong political signal in support of the European Union Youth Orchestra. Germany and Ireland also made clear their desire to ensure secure future funding of the EUYO at the meeting of EU culture and media ministers on 27 November 2018. Nonetheless, Germany, Ireland and Italy acknowledge that specific inclusion in the regulation text of an entity to be funded should generally remain the exception."
