Subject: Temporary reintroduction of border control at internal borders – notification on the basis of articles 23 (1) and 24 of the Schengen Borders Code (Regulation 562/2006)

Dear Mr. Bizjak

In accordance with article 23 of the Regulation n.º 562/2006 of the European Parliament and of the Council establishing a Community Code on the rules governing the movement of persons across the borders (Schengen Borders Code) the Portuguese Government decided to reintroduce border control at its internal borders as a result of increased security requirements for the forthcoming NATO Summit in Lisbon, on 19 and 20 November 2010, at the level of Heads of State and Government.

Between the 16 November 2010 at 00h00 and the 20 November 2010 at 24h00 border control will be reintroduced in order to minimise the risk of threat to public policy, public security and public order in connection with this event.

Border checks will be carried out on following Border crossing points (BCP's):

## Air borders

 Airports of Lisbon, Faro, Porto, Madeira (Funchal e Porto Santo) and Açores (João Paulo II, Santa Maria e Aeroporto Civil das Lages).
