Graduate of the University of Paris I (DESS in economics) and of the Paris Institut d'Etudes Politiques

Joined Electricité de France in 1974.

Following a number of posts in administration, operational management and management control in the EDF General Affairs, Equipment (nuclear, conventional thermal and hydraulic engineering), and Production and Transport Departments, both in operational units and central departments, was given responsibility for setting up the internal audit office of the Production and Transport Department in 1991.

In 1994 joined the Fuels Division as head of accounts, management control, information and human resources and was also appointed as a director and subsequently as President of ATIC Services (logistics services, relating in particular to coal supplies for EDF, USINOR and CDF Energie); carried through privatisation of the company.

In 1997 appointed to the Financial Division of EDF as Head of Department responsible for control of central functions and subsequently Deputy to the Financial Management Director of the Energy Branch, which covers all EDF means of production in France, engineering, commercial functions on the wholesale market, trading and optimisation of the electricity system.

Since June 2002, as Head of the Uranium/Fossil Fuels Branch of the EDF's Fuels Division, has been responsible for uranium procurement, conversion and enrichment services, definition of contract negotiation and conclusion strategies and supplies of coal and fuel oil.

Is also General Manager of the Société Auxiliaire d'Energie, a holding company for EDF shares in various subsidiaries in the field of fossil and nuclear fuels, and in that capacity is a director of some of those subsidiaries.

His duties include responsibility for relations with the Euratom Supply Agency.

Note: Eurodif is the Areva Group's uranium enrichment company. It has Spanish, Belgian, Italian and Franco-Iranian shareholders, but the majority stake is held by France through Cogema. With 35 customers in Europe, the United States and Asia, Eurodif has a 25 per cent share of the world market in uranium enrichment. Eurodif's Tricastin site is one of the world's largest electricity consumers: its plant can supply about 100 nuclear reactors with enriched uranium and consumes the energy output of three reactors, i.e. more than the city of Paris.
