Small farmer payment

The SCA considered the suggested Presidency amendments concerning the small farmer payment as set out in doc. 14149/1/12 REV 1. The <u>SCA</u> noted the Presidency's summary, the main elements of which were as follows:

- There was considerable support for the Presidency's suggested amendments to the calculation method as a step in the right direction.
- Delegations' comments on other aspects of the scheme, their scrutiny reserves, as well as the comments from the Commission representative were noted.

Greening and greening penalties

The <u>SCA</u> considered the suggested Presidency amendments to the greening provisions as set out in doc. 15874/12, along with the Presidency note on penalties for non-compliance with greening requirements as set out in doc. 15854/12.

The <u>SCA</u> noted the Presidency's summary, the main elements of which were as follows:

- The views expressed were to be considered as <u>preliminary</u>, the scrutiny reserves of many delegations were noted, as were the requests for further discussion on other aspects of greening, including the Ecological Focus Areas in Article 32.
- While there was <u>some support</u> for the suggestion to partially de-link the greening payment from the basic payment while allowing greening penalties to go beyond the greening payment, requests for clarification and suggestions for improvement were noted.
- While a <u>large number of delegations</u> considered that a mount of any greening penalty should not be higher than the total greening payment amount, <u>some delegations</u> acknowledged that this could be the case for serious infringements.
- On the issue of equivalence, there was <u>broad support</u> for the suggested approach to recognise that the greening requirements could also be considered to be fulfilled by farmers participating in either second-pillar Agri-Environment/Climate Schemes or national or regional Environmental Certification Schemes, provided such schemes would generate at least equivalent benefits for the environment and/or for the climate as the greening practices proposed by the Commission.

- On the issue of "green by definition" in relation to permanent grassland, a <u>large number of delegations</u> could go along with the Presidency's suggestion that farms with at least 75% of permanent grassland or land used for growing grass or other herbaceous forage should be considered as "green by definition". <u>Some delegations</u> preferred a lower rate than 75%.
- On the maintenance of permanent grassland, the approach suggested by the Presidency was broadly supported as a step in the right direction.

The <u>SCA</u> also noted delegations' other comments and the comments made by the Commission representative, as well as the Presidency's invitation to delegations to send their written contributions to the Council Secretariat by 14 November 2012 close of business with a view to coming back to this issue at a next meeting.
