### STATEMENT 205/03

# **Commission statement re Article 1**

"In order to ensure that the fishing effort related to fisheries for scallops, edible crab and spider crab in ICES divisions VIId and VIIe is managed appropriately, the Commission will propose a management plan for these stocks in accordance with Article 6 of Council Regulation (EC) No 2371/2002.

In order to ensure interim implementation of the above plan as of 1 January 2004, the Commission will include provisions on fishing effort limitations for these stocks in the TAC and quota proposal for 2004."

#### **STATEMENT 206/03**

### **Statement by the Council and the Commission re Article 3**

"Where the provisions of Article 3 permit access by certain fishing vessels to waters from which they were previously excluded, the Commission and the Member States concerned shall carefully monitor fishing activities in the area concerned in order to ensure that such activities are consistent with the measures already in place for the conservation of fishing resources."

#### STATEMENT 207/03

## **Commission statement re Article 3**

"The demersal fisheries referred to in Articles 3 and 6 include bottom trawl fisheries for Norway lobster and shrimp."

### **STATEMENT 208/03**

#### **Commission statement re Article 5**

"To complement the limitations on access laid down in paragraph 1 of Article 5 and to avoid damage to the sensitive eco-systems on seamounts occurring in waters at least up to 200 miles surrounding the Azores, Madeira and the Canary Islands, the Commission intends shortly to propose to the Council an amendment of Council Regulation (EC) No 850/98 under which fishing with trawl gears in the aforementioned waters surrounding the Azores, Madeira and the Canary Islands would be prohibited."

#### **STATEMENT 209/03**

### Statement by the Council and the Commission re Article 5

"The provisions concerning outermost regions in this Regulation do not prejudge the measures to be adopted at a later stage in respect of the French Overseas Departments. The Commission intends to present a proposal on this issue during 2004."

#### **STATEMENT 210/03**

### **Commission statement re Article 5**

"When implementing the rules for the provisions of paragraph 1 of Article 5, the Commission will include, as part of the Community vessels having traditionally fished in outermost regions, those vessels operating under existing agreements between Member States."

### **STATEMENT 211/03**

### **Commission statement re Article 11**

"When drawing up its proposal referred to in paragraph 1 of Article 11, the Commission will ensure that all the Member States concerned are fully informed and consulted on the maximum levels of fishing effort proposed for other Member States."

# **STATEMENT 212/03**

### **Commission statement re Article 12**

"In cases where the Commission is requested to permit an increase of the maximum fishing effort for a Member State in a particular area or division in order to allow the Member State to fish for non-regulated species, it has to be demonstrated that this will not lead to an increased bycatch of regulated species for which Member States no longer have quotas, if the Commission is to accept such a request."

### **STATEMENT 213/03**

# Statement by the Spanish delegation

"With regard to the adoption by the Council of the Regulation on the fishing effort relating to Western Waters, the Spanish delegation would make the following statement:

- 1. Spain repeats that, as confirmed by the Legal Service of the Council of the European Union, the rules included in Regulations No 685/95 and No 2027/95 concerning the adaptation of the rules governing the transitional period prior to Spain's full integration into the Common Fisheries Policy ceased to be effective from 1 January 2003. This fact is not nullified by the specific date of repeal set for those Regulations in Article 15(1) of the Council Regulation on the management of the fishing effort relating to certain Community fishing areas and resources and modifying Regulation (EEC) No 2847/93.
- 2. Spain considers that the reference period 1998-2002 given in Articles 3 and 6 of the Regulation for assessing the levels of fishing effort exerted by the different fishing fleets and thereby determining the ceiling for the fishing effort which may be exerted by each Member State in future is a period during which discriminatory effort restrictions were applied to the Spanish fleet as a result of its transitional arrangements.
- 3. Spain considers that the specific measures adopted for the area defined in Article 6 of the Regulation are inappropriate from a technical viewpoint and are not justified because they entail different treatment for certain Member States for reasons that are not objective and which may constitute discrimination on grounds of nationality.
- 4. Spain reserves the right of recourse to the Court of Justice to defend its rights."

#### **STATEMENT 214/03**

#### **Commission statement**

"<u>The Commission</u> takes note of the agreement reached by the European Parliament and the Council in second reading on the proposal for a Regulation concerning monitoring of forests and environmental interactions in the Community (Forest Focus).

The Commission must, however, recall the terms of the statement it made at the time of the adoption of the common position, as follows:

The Commission takes note that the Regulation of the European Parliament and the Council provides for a regulatory procedure regarding the implementation measures detailed in the proposal, as opposed to the management procedure proposed by the Commission.

In the light of the judgement of the Court of Justice of 21st January 2003 in respect of Regulation (EC) 1655/2000 concerning the financial instrument for the Environment (LIFE), the Commission insists on the importance of applying the criteria of Article 2 of Council Decision 468/99/EC of 28 June 1999, laying down the procedures for the exercise of implementing powers conferred on the Commission.

The Commission believes that as the measures detailed in the proposal relate to the implementation of programmes with substantial budgetary implications they should be adopted by use of the management procedure. The measures are quite specific to the programme, therefore they are not general in scope, nor are they designed to apply, adapt or update the provisions of the instrument. For these reasons, the Commission does not consider the Regulatory procedure to be appropriate.

In accordance with the Judgement of the Court of Justice mentioned above, any choice of procedure which does not comply with the criteria for guidance contained in Article 2 of the Council Decision on the exercise of implementing powers conferred on the Commission must be clearly explained.

The Commission considers that in this case the text of the recital specifying the use of the comitology procedure does not sufficiently justify departing from the criteria contained in the Council Decision.

The Commission therefore reserves its right to make use of the legal means at its disposal."

### **STATEMENT 215/03**

# Statement by the Finnish and Belgian delegations

"<u>Finland and Belgium</u> recall that the objective of the Forest Focus Regulation is to monitor forests and their environmental interactions. Forest fire prevention measures are eligible for support under Regulation (EC) No 1257/99.

The Finnish and Belgian position is that forest fire prevention measures should only be financed through one instrument. Therefore, Finland and Belgium believe that after 31 December 2006 forest fire prevention measures should not be financed under the Forest Focus Regulation but rather, for example, through Regulation (EC) No 1257/99."

# **STATEMENT 216/03**

# Statement by the Swedish delegation

"Sweden is a country with an important forestry sector. As clarified in a declaration at the adoption of the common position, Sweden has major problems in principle with the proposed regulation. In a spirit of compromise, Sweden decided however to vote for the common position. Regretfully, negotiations with the European Parliament have resulted in a compromise, which goes even further in the wrong direction. As it now stands, the proposal does not, in Sweden's view, sufficiently fulfil the initial intentions to divide monitoring and preventive measures. Specifically regarding forest fire prevention measures, Sweden is not opposed to Community measures, but finds the existing Regulation (EC) 1257/99 the adequate legal act to be applied. For these reasons Sweden votes against the compromise with the European Parliament."

# STATEMENT 217/03

# **Statement by the United Kingdom delegation**

"The United Kingdom has not felt able to support the proposal to require all eggs at local public markets to be marked. The Commission has produced no evidence demonstrating that there is actually a food safety or enforcement problem that needs to be addressed. The proposal is therefore likely to lead to unnecessary additional burdens on small-scale producers. A facultative provision, allowing those Member states which do have concerns about local markets to take necessary action, would have been more appropriate."

# STATEMENT 218/03

## **Council statement**

"Referring to the joint statement made by the Council and Parliament (Ecofin 16 July 2003, doc. 11183/03) concerning the adjustment after the Enlargement of the reference amounts in legal bases agreed upon jointly with the Parliament, the Council hereby states that for the Erasmus Mundus and *e*Learning programmes the conditions of this joint statement have been fulfilled."

## **Council statement**
