Subject: List of Global Gateway flagship projects – updates and consolidation

---

1. The yearly flagship projects exercise is carried out in line with the Global Gateway governance (ST 13888/22 REV 1) with the input from the Commission, the EEAS and the Member States taking into account the criteria for identifying flagships (ST 10532/22) and the political priorities identified both by the EU, the Member States and our partners. The previous flagship projects were all endorsed by COREPER as follows: flagship projects for 2025 (ST 15281/24), flagship projects for 2024 (ST 15369/1/23), and the flagship projects for 2023 (ST 6738/23).
2. RELEX HQ has discussed the Presidency-proposed approach to the revision of the flagship list at its meetings on 11 July 2025, 3 October 2025, 7 November 2025.
3. Drawing on the insights from the 2023, 2024 and 2025 flagship list exercises, it is essential to keep the list as concise and focused as possible to ensure it serves its communication purpose. The current exercise updates all flagship projects and consolidates them into one list.

4. Based on input by the Commission and the Member States, the Presidency prepared an updated and consolidated proposal for a list of Global Gateway flagship projects. It was negotiated via a written procedure.
5. Agreement on working party level was reached on 4 December 2025.
6. In line with the Global Gateway Governance defined in document ST 13888/22 REV1, COREPER is therefore invited to endorse the consolidated and updated list of Global Gateway flagship projects.
