5. CAP reform

(i) Proposal for a regulation of the European Parliament and of the Council establishing rules for direct payments to farmers under support schemes within the frame work of the common agricultural policy

The <u>SCA</u> considered further Presidency suggested amendments to the **greening** provisions in Articles 29-33 (doc. 15874/1/12 REV 1).

The <u>SCA</u> noted the general reservation entered at the outset by <u>some delegations</u> for whom the issue of greening was linked with the ongoing discussions on the Multiannual Financial Framework.

Thereafter the SCA took note of the Presidency's concluding remarks that:

- while delegations remained generally positive about the steps made towards equivalence to greening practices, the Presidency would reflect on their suggestions, including in their written comments (doc. 16246/12 ADDs 1-14), for a simpler and more workable approach;
- on the articulation of greening with the baseline under the 2nd pillar the Presidency would reflect on ways forward.

The SCA also noted delegations' other detailed comments and their scrutiny reserves, as well as the comments made by the Commission representative.

As regards the Presidency suggestions regarding the use of the non-opinion clause (doc. 16083/12), the SCA noted the Presidency's conclusion that the Presidency suggestions had received the support of a <u>majority of delegations</u> and that the comments and scrutiny reserves entered by a <u>few delegations</u> had been noted.

Furthermore the SCA took note of the draft Regulation prepared by the Presidency (doc. 16223/12 ADD 1), and of the Presidency's explanation that this was intended to represent a fair and faithful reflection of progress made and of the settled view of the SCA, while acknowledging that the open political issues marked in square brackets remained ring fenced at this stage. The SCA further took note of the comments made by delegations and of the scrutiny reserves entered. The <u>SCA</u> finally took note of the Presidency's intention to reflect, in the light of the points made by delegations and of developments in the discussions on the Multiannual Financial Framework, on how to take work forward.

The <u>SCA</u> took note of the positions of delegations and of the Commission together with the scrutiny reserves entered, on:

- a) recognition of producer organisations, their associations, and inter-branch organisations, and
- b) specific marketing standards, including labelling of the place of farming and/or origin on the basis of the working documents 16248/12 and 16247/12.

At the conclusion of the discussions the <u>SCA</u> took note that in the view of the Presidency while on both issues delegations had diverging opinions, on each issue there was considerable support for the status quo.

The <u>SCA</u> also took note of the Presidency's intention to reflect further on these issues and to come back to them at a later stage.

Furthermore the <u>SCA</u> took note of the draft Regulation prepared by the Presidency (doc. 16223/12 ADD 2), and of the Presidency's explanation that this was intended to represent a fair and faithful reflection of progress made on the proposal and of the settled view of the SCA while acknowledging that the open political issues marked in square brackets remained ring fenced at this stage. The SCA further took note of the comments made by delegations, as well as of the scrutiny reserves entered and of the comments made by the Commission representative.

- The SCA took note of delegations' views on the irrigation, investments and forestry provisions as set out in Presidency's notes 16230/12, 16186/12 and 16187/12. With regard to investments, the <u>SCA</u> took note of the Presidency's intention to withdraw the new paragraph 4a in Article 18.
- The SCA also took note of delegations' views and of the comments made by the Commission representative on the consolidated text of the Regulation set out in document 16223/12 ADD 3. The Presidency noted that a number of delegations had scrutiny reservations on the entire text of the draft regulation.

(iv) Proposal for a regulation of the European Parliament and of the Council on the financing, management and monitoring of the common agricultural policy (the horizontal regulation)

The SCA took note of delegations' views on the Presidency's consolidated text set out in document 16223/12 ADD 4, of delegations' views on the text of Articles 54 and 55 and on GAEC 7 and of the comments made by the Commission representative. The Presidency noted that a number of delegations had scrutiny reservations on the entire text of the draft regulation.

The SCA considered the further Presidency suggested amendments concerning the processing and protection of personal data as set out in docs. 15665/1/12 REV 1 (draft Horizontal Regulation), 15982/12 REV 1 (draft Rural Development Regulation), 16050/1/12 REV 1 (draft Direct Payments Regulation) and 16045/1/12 (draft Single CMO Regulation), with a slightly revised version of the latter two documents distributed during the meeting (and thereafter distributed with reference 16050/2/12 REV 2 and 16045/2/12 REV 2).

The SCA noted the comments from the representative of the Council Legal Service and from the Commission, as well as the conclusion from the Presidency that, in the absence of any comments by Friday 23 November close of business, the suggested amendments would be considered to be approved.

7. Nomination of members of the Steering Board for the European Innovation Partnership on Agricultural Productivity and Sustainability

The SCA agreed, on the basis of a recommendation from the Presidency, on the nomination of representatives from Member States to the Steering Board referred to in Council conclusions on the European Innovation Partnership Agricultural Productivity and Sustainability. The SCA invited the Council to adopt Council conclusions endorsing the agreement reached.
