Ad "B" item 3: Conclusions on the future of European competitiveness Approval

STATEMENT BY AUSTRIA

"In view of the global competitive dynamics, it is essential that a holistic strategy for promoting competitiveness and productivity will be further developed in order to close the growth and innovation gaps between Europe and competing third countries.

However, Austria states a critical position on the following topics of the Presidency Conclusions:

- 1. Reduction of reporting requirements: The reduction of unjustified administrative burden and reporting requirements for industry and SMEs respecting existing standards is key. The statements in para 5, in particular on "reality checks" and the "Think Small First" principle, should remain, and the reduction of reporting requirements beyond the 25% target should be implemented quickly using a specific methodology.
- 2. <u>Nuclear energy</u>: Austria maintains the view that only those technologies that are safe, sustainable and environmentally sound, particularly renewable energy technologies should be promoted. For the Austrian government, any reference to clean energy and clean technologies does not encompass nuclear power.
- 3. <u>Financing</u>: Austria welcomes the fact that the Presidency Conclusions reject any prejudgement of the upcoming MFF negotiations. Austria is also opposed to further debt mutualisation. Investments must be financed in particular by mobilising private funds. In line with the Eurogroup+ declaration on competitiveness, as public funds must be utilised effectively."

STATEMENT BY GERMANY

"Germany expressly supports the objectives of the conclusions on the future of European competitiveness.

The Council conclusions contain many important points with a view to the future work program of the new Commission. Strengthening EU competitiveness is the central challenge and task of the new legislature. We also welcome the emphasis in the conclusions on education, research and innovation as key to competitiveness.

The Draghi report is an unmistakable wake-up call. Strengthening EU competitiveness must go hand in hand with the continuation and further development of the Green Deal agenda as a driver of growth, investment and innovation, the acceleration of the digital transformation and the preservation of social cohesion. We need a horizontal, cross-sectoral improvement in economic framework conditions. This requires, in particular, the future-oriented further development of the internal market, tangible progress in reducing bureaucracy and speeding up procedures while maintaining necessary protection standards, a reduction in energy prices, measures to secure skilled workers, strengthening research and innovation and an ambitious trade agenda based on openness.

We therefore generally welcome the language on the single market. We also welcome the fact that economic security and the reduction of dependencies are mentioned as the third pillar of the Draghi report in the Council conclusions. It will be important that the Clean Industrial Deal takes a holistic and comprehensive approach that provides the right incentives for innovation, transformation, investment and thus inclusive growth and technological sovereignty.

Despite our support for the above-mentioned points, Germany could not agree to the Council conclusions:

Germany is of the opinion that EU funding can only be used to support technologies that are safe, sustainable and environmentally friendly and for which targets exist at Union level. This is not the case for nuclear energy from nuclear fission (nuclear power). The German government had advocated a formulation that respects the energy sovereignty of the Member States. This is not sufficiently reflected in paragraph 15 of the Council Conclusions. The German government therefore could not agree to the text."
