Suġġett:	Miżuri restrittivi fid-dawl tal-azzjonijiet tar-Russja li jiddestabilizzaw is-sitwazzjoni fl-Ukrajna - prenotifiki

1. Fil-31 ta' Lulju 2014, il-Kunsill adotta d-Deċiżjoni 2014/512/PESK u r-Regolament (UE) Nru 833/2014 dwar miżuri restrittivi fid-dawl tal-azzjonijiet tar-Russja li jiddestabilizzaw is-sitwazzjoni fl-Ukrajna. Dawn il-miżuri ġew estiżi għall-aħħar darba bid-Deċiżjoni (PESK) 2023/1517 sal-31 ta' Jannar 2024.
2. Fit-18 ta' Diċembru 2023, il-Grupp ta' Hidma ta' Kunsillieri għar-Relazzjonijiet Barranin (RELEX) qabel dwar abbozz ta' avviż li għandu jiġi ppubblikat fil-Ġurnal Uffiċjali serje C, u dwar l-abbozz ta' mudell ta' ittri ta' prenotifika, kif jinsabu fl-Annessi ta' din in-nota.
3. F'dawn iċ-ċirkostanzi, il-COREPER huwa mistieden:
 - jikkonferma l-qbil dwar l-abbozz ta' avviż u l-abbozz ta' mudell ta' ittri ta' prenotifika;
 - jiddeċiedi, f'konformità mal-Artikolu 12 tar-Regoli ta' Proċedura tal-Kunsill, li l-Kunsill juża l-proċedura bil-miktub biex japprova:

- l-avviż kif jinsab fl-Anness I ta' din in-nota;
- l-abbozz ta' mudell ta' ittra lill-entitajiet u/jew ir-rappreżentanti tagħhom li jistgħu jitolbu aċċess għall-fajl tagħhom abbazi tal-avviż, kif jinsab fl-Anness II ta' din in-nota;
- l-abbozz ta' mudell ta' ittra lill-entitajiet li l-indirizz tagħhom huwa disponibbli, kif jinsab fl-Anness III ta' din in-nota.

Avviż għall-attenzjoni ta' ċerti entitajiet soġġetti għall-miżuri restrittivi previsti fid-Deċiżjoni tal-Kunsill 2014/512/PESK u r-Regolament tal-Kunsill (UE) Nru 833/2014 dwar miżuri restrittivi fid-dawl tal-azzjonijiet tar-Russja li jiddestabilizzaw is-sitwazzjoni fl-Ukrajna
