On behalf of the EU and its Member States, we would like to thank Mr. George Kremlis, Chair of the Bureau, for re-opening the high-level segment of the resumed MoP9/MoP5 sessions. By resuming the joint meeting of the Parties to address the matters set out in the agenda, it offers a possibility to officially close the MoP9/MoP5 session that was regretfully not possible to be closed in 2023.
