

General approach

## STATEMENT BY FINLAND

"Finland endorses the general approach agreed by Member States in the Environmental Council of 18 December 2023.

Finland agrees with the targets and objectives of the packaging and packaging waste regulation and with the necessity of reducing the amount of packaging waste in order to reach the EU's overall circular economy targets.

Finland considers that while overall the general approach provides a good basis for further negotiations with the co-legislators, there are still some concerns related to the text. Finland believes that the most notable shortcoming in the general approach relates to the lack of derogation possibility on reuse targets in articles 22 and 26 based on assessment of overall environmental impacts.

Prioritising reuse over single use should be based on reliable and scientific evidence. Finland sees that single use with appropriate recycling should be taken into account as environmentally sound option for reuse when justified by a life cycle analysis. Finland regrets that the Council has not addressed this issue in its general approach and will continue working for this to be taken into consideration in further negotiations between the co-legislators."
