Delegations will find attached for information a revised table concerning the implementation of Council Framework Decision 2006/783/JHA of 6 October 2006 on the application of the principle of mutual recognition to confiscation orders (OJ L 328, 24.11.2006, p. 59).

The information is based on notifications by Member States to the Council General Secretariat, to which reference is made in the last column of the table.

In accordance with Article 22, the Framework Decision should have been implemented by 24 November 2008.

According to the information received, all 27 Member States (BE, BG, CZ, DK, DE, EE, EL, ES, FR, HR, IE, IT, CY, LV, LT, LU, HU, MT, NL, AT, PL, PT, RO, SI, SK, FI and SE) have implemented the Framework Decision in their national legal order and have made the necessary notifications/declarations.

The information in the table is a summary of the notified information: delegations are invited to consult the documents referred to in the last column in order to obtain more detailed information.
