#### 3. CAP reform

- (i) Proposal for a regulation of the European Parliament and of the Council establishing rules for direct payments to farmers under support schemes within the framework of the common agricultural policy
  - Greening

- Orientation debate

<u>The SCA</u> considered further Presidency suggested amendments to the greening provisions set out in doc. 15874/2/12 REV 2.

<u>The SCA</u> noted the Presidency's explanations on the suggested changes and on a number of minor corrections (these were incorporated in the further revised version of the text distributed with reference 15874/3/12 REV 3).

<u>The SCA</u> also noted the scrutiny reserves entered by <u>delegations</u> and the preliminary views on the text expressed by <u>delegations</u> and by the <u>Commission representative</u>, with <u>several delegations</u> reiterating their general position that the issue of greening was linked to ongoing discussions on the Multiannual Financial Framework 2014-2020.

17182/12 DG B Thereafter, the <u>SCA</u> took note of the Presidency's concluding remarks, in particular:

- that <u>most delegations</u> welcomed the suggested amendments as a step in the right direction, but that further technical work was needed;
- that the <u>Presidency</u>, following the encouragement from delegations, would take work forward on greening at the SCA meeting on 10 December 2012, on the basis of a slightly adjusted text;
- that delegations were welcome to submit written contributions.

<u>The SCA</u> took note of the Presidency suggested legal improvements to Articles 154 and 156 on exceptional measures (document 16925/12), of the comments made by delegations and the Commission representative, and of the scrutiny reserves entered.

<u>The SCA</u> further took note of the Presidency's conclusion that many delegations considered the text to be a good compromise.

Finally the <u>SCA</u> took note of the Presidency invitation to delegations to lift their scrutiny reserves or send written comments by Tuesday 4 December close of business.

The SCA took note of the Presidency information on the state of play of the adjusted provisions on data protection in the context of the draft Regulations on Direct payments and Single CMO (documents 16050/2/12 REV 2 and 16045/2/12 REV 2 respectively). The SCA also took note of the comments made by delegations and the Council Legal Service, and of the scrutiny reserves entered.

Finally the <u>SCA</u> took note of the Presidency conclusion that in its view these texts reflected the centre of gravity in the Committee.
