3. Proposal for a Regulation of the European Parliament and of the Council amending Council Regulation (EC) No 1234/2007 as regards marketing standards

The SCA approved the Council position, including on the suggested Presidency amendments on the four issues identified by the Presidency (set out in doc 16004/11, page 2 under (a)) with the exception of the following issues which remain open and on which delegations' reserves were noted:

- the empowerment of the Commission to adopt further specific marketing standards under the delegated acts procedure (Article 112e(1));
- the scope of the requirement on "place of farming and/or origin" (Article 112e(2)(j)).

On this basis the SCA provided the Presidency with a partial mandate for a first informal trilogue.

The SCA further noted the deadline set by the Presidency of Wednesday 23 November, 12.00, for delegations to submit any further comments in writing.
