The SCA took note of a Presidency compromise proposal. Due to the late arrival of this document, the Presidency invited delegations to send their comments in writing to the General Secretariat of the Council by Wednesday 30 November 2011, 12h00. The Presidency intends to revise the Presidency compromise on the basis of the Member States' comments and to come back to this issue at the next meeting of the SCA on 5 December 2011.
