The Committee had an exchange of views on the basis of the Presidency note, the SIS Task Force Report and the notes and communications from DE, AT and the Commission. The Presidency signalled its intention to report to Council taking account of the outcome of the discussions. The Presidency also underlined the necessity for clarity and transparency as well as the need for continued monitoring of the project.

## 3. Danish Presidency priorities

## 2. Implementation of Prüm Decision – orientation debate doc. 16757/11 JAI 825 CATS 109 DAPIX 146 ENFOPOL 395 ENFOCUSTOM 134

The Committee's debate focused, on the one hand, on support for non-operational Member States and, on the other hand, on lessons to be drawn both on drafting and on implementation of future legislation which would be as technically demanding as the "Prüm Decisions". Delegations which underlined the importance of the Prüm automated data exchange for effective law enforcement voiced concerns about the unsatisfactory state of implementation. They invited Member States lagging behind to intensify their implementation efforts. However, delegations admitted that the Prüm implementation presented complex challenges. Against this backdrop, the set up of the Ad hoc Group on Information Exchange, now DAPIX, was deemed an appropriate solution. It was recommended to draft future legislation implying such extensive technological information exchange in line with the IMS. Furthermore, several delegations welcomed the specific support offered by the operational Member States and, moreover, by the Mobile Competence Team (MCT) and the future helpdesk briefly presented by DE and Europol respectively. The Commission also welcomed the MCT as a good example of mutual support and was confident that Europol tackle the specific tasks without increasing its budget. The Commission reiterated its readiness to continue providing ISEC funding for the

implementation of the Prüm Decisions but reminded Member States of not having used those funds to the extent possible. In this context, delegations that applied for ISEC funds stressed the need for a more facilitated access to EU funding. Before submitting similar legislation, a proper impact assessment and clear estimates as well as information about specific funding programs were deemed crucial to allow for the allocation of human and financial resources at national level. Furthermore, a common project management with detailed reporting and monitoring was recommended.

The Presidency presented its note. The Commission indicated that, whilst it had understanding for the Member States' concerns, it had no budget line to fund the establishment of the passenger information units and was opposed to the insertion of an article in the draft PNR Directive imposing financial obligations to that effect. It was, however, willing to use existing financial funds to support Members States in the establishment of the passenger information units. According to the Commission, running costs of any system set up further to EU legislation, in principle have to be borne by the Member States. A vast number of Member States stated that they were in favour of an article which would imply a binding commitment on the part of the Commission to allocate the necessary financial means from the EU budget to that end. A few delegations also referred to other questions related to the draft directive, such as data protection, proportionality and the added value of any PNR system as compared to existing systems for collecting data (API Directive) or analysing data (Europol).

# - Draft Council Resolution on the future of customs cooperation in the enforcement rea

CATS approved the 6-month report on the activities of the CCWP during the Hungarian Presidency (1 January - 30 June 2011) and took note of the draft Council Resolution on the future of customs cooperation in the enforcement area following the explanatory remarks of the CCWP chair who briefly outlined the main issues addressed by the draft Resolution. CATS held an orientation and strategic debate on the closer cooperation between customs and other law enforcement authorities, including under the Naples II Convention. Delegations, while agreeing that the core discussion would be held in COSI and at working party level (CCWP/LEWP), welcomed the opportunity to provide their preliminary views. They shared the view that customs make a significant contribution to the process of monitoring goods entering the EU together with the other law enforcement authorities, however that cooperation still can be reinforced. Some delegations pointed out that the different competences and structure of Member States' customs authorities should be taken into account. Europol expressed the view that being a multiagency organisation, its strategic and operational assistance is devoted to all law enforcement authorities including customs. However it is also determined to provide them with a more dedicated support, comprising the possibility to use Europol's database for the purposes of JCO, to benefit from pan-European analyses and host operational meetings at its premises, and also urged Member States to facilitate customs access to the Secure Information Exchange Network Application (SIENA).

The Committee discussed the Presidency note on complementarity. While supporting its objectives in general, several delegations (CY, ES, FR, PT, NL) commented to the note. The Presidency would take these comments into consideration before a final discussion in JAIEX on 2nd December.

The Committee was given information by representatives of the Secretariat of the Council of Europe (CoE) on the opinion on the proposed Directive on access to a lawyer, which it had provided on request by the LIBE Secretariat of the European Parliament. The representatives of the CoE Secretariat also answered questions posed by some delegations, and they indicated that once the Council would have a more mature text, the CoE Secretariat would be ready to have a look again at the compatibility of such text with the European Convention on Human Rights, as interpreted in the case-law of the European Court of Human Rights.
