The Presidency, on the basis of the lunch discussion, concluded that there was broad support for the approach set out in doc. 18196/1/11 which it was agreed should provide the basis for work under the incoming Presidency. The need to resolve the issue of the legal basis had also been noted.

The Presidency also noted that there was support for the suggestion that the Mixed Committee should have a new and strengthened role for the purpose of ensuring political guidance and management of the Schengen area.

EL stated that it maintains a reservation on Article 7(3), and the Commission maintains a number of reservations, as indicated in the footnotes. The outcome of proceedings is set out in 18691/11. On the basis of this approach, the incoming Presidency will start negotiations with the European Parliament.
