NOTING that most OACPS Member States affected by the EU Regulation on Deforestation-free Products are not ready and require additional time and resources to be compliant;

DEEPLY CONCERNED that the transition period ends soon on 31 December 2024;

RECOGNISING that 70% of OACPS member states—are commodity-dependent and mainly export agriculture or mineral commodities, thereby compelling them to prioritise value addition, beneficiation, and industrialisation as critical aspects for sustainable economic growth and development;

HEREBY DECIDES TO:

- 1. Mandate the Committee of Ambassadors to:
 - Engage with the EU to establish a dedicated EPA-related fund to cover the cost of trade compliance arising from the implementation of EPA provisions, including those on trade and sustainable development;
 - ii) Follow-up with the European Commission on accompanying measures required to enable OACPS Member States to comply with the new EU rules on sustainability, such as deforestation regulations, the Carbon Border Adjustment Mechanism, the Corporate Sustainability Due Diligence Directive, and the Forced Labour Regulation; and
 - iii) Initiate the process of promoting deeper trade integration among OACPS Member States, including potentially allowing OACPS EPA signatory states to mutually grant one another market access equivalent to that offered to the EU, and to begin reviewing specific policies aimed at increasing intra-OACPS trade cooperation;

- 6. **Also impose** a moratorium on the recruitment of staff at the OACPS Secretariat, except for the position of Internal Auditor, which is necessary to strengthen the Organization's financial governance framework.
- 7. **Impose** a moratorium on payment of salary-in-lieu-of-leave for the remainder of 2024, and **request** that, in this regard, the Committee of Ambassadors in consultation with the Secretariat, implement this decision in line with the relevant Staff Regulations.

 - ii) **Propose** additional changes to be made to the Financial Regulations in keeping with international standards, to ensure that strong guardrails and accountability frameworks are in place, and report to Council at its next Session outlining recommendations for amendment to the Financial Regulations, including clear provisions on the consequences of financial breach; and
 - iii) Review the OACPS scale of contributions to the Secretariat's budget, in accordance with Decision No 4 /XCV/12 of the 95th Session of the Council of Ministers
