The SCA confirmed that it had no intention to object to the delegated act and it assumed that the Council does not intend to object to it.

4. **Proposal for a Regulation of the European Parliament and of the Council on organic production and labelling of organic products, amending Regulation (EU) No XXX/XXX of the European Parliament and of the Council [Official controls Regulation] and repealing Council Regulation (EC) No 834/2007**

- Partial general approach (articles 1-19 and corresponding annexes)

The Presidency submitted a compromise text with the objective to reach a partial General approach at the "Agriculture and Fisheries" Council on 15/16 December. Although acknowledging the hard work undertaken by the Presidency on this dossier and the good progress achieved so far, many delegations were not in a position to support the partial general approach. These delegations were of the view that a progress report would be more appropriate.

In addition, the Presidency submitted a text, "Council political orientations for the future debate on the organic proposal", summarising the main achievements reached on this dossier and providing political guidance for future work, with the view of submitting it also to the Council for approval. The Presidency requested delegations to provide their position on this text by next Thursday noon.

The SCA took note of the Presidency progress report as set out in document 15891/14, of the views expressed by delegations as well as of the comments made by the Commission representative. Furthermore the SCA took note of the statement made by the Hungarian and Czech delegations that it would be preferable to keep the two schemes separate. The Hungarian delegation also expressed its opposition to other elements of the proposal. The SCA took note of the Presidency's intention to present a slightly revised progress report for the Council to take note at its meeting on 15-16 December 2014.

The SCA had a discussion on the Presidency revised draft Council conclusions as set out in document 16030/1/14 REV 1 and took note of the comments made by delegations and by the Commission representative.

The SCA unanimously approved the draft Council Decision, with the Belgian, Danish, Netherlands and UK delegations indicating their intention to abstain when voting. The SCA also agreed that after the completion of the legal-linguistic revision exercise, the draft Council Decision be submitted directly to the Council for adoption in its final version to be set out in document 15254/14.
