Subject:	Transfer of appropriations No DEC 27/2019 within Section III - Commission - of the general budget for 2019

1. On 3 January 2020, the Commission submitted to the Council proposal for transfer of appropriations No DEC 27/2019.

The purpose of this proposal is to transfer a total amount of EUR 255.5 million in payment appropriations from 33 budget lines under various headings of the multiannual financial framework to Articles 04 02 60 (*European Social Fund - Less developed regions - Investment for growth and jobs goal*) and 11 06 60 (*Promoting sustainable and competitive fisheries and aquaculture, balanced and inclusive territorial development of fisheries areas and fostering the implementation of the common fisheries policy*), and to Item 05 04 60 01 (*Promoting sustainable rural development, a more territorially and environmentally balanced, climate-friendly and innovative Union agricultural sector*), as recorded in document 5007/20.

- 2. In accordance with Article 31(2) of Regulation (EU, Euratom) No 2018/1046 of the European Parliament and of the Council on the financial rules applicable to the general budget of the Union¹, this so-called "End-of-Year Transfer" aims to cover outstanding claims and to reimburse Member States for payments already undertaken in shared management.
- 3. <u>The Budget Committee</u> examined this proposal for a transfer at its meeting on 7 January 2020.
- 4. Following that examination, <u>the Budget Committee</u> agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
 - the proposed transfer of appropriations;
 - the draft letter in the ANNEX to that effect.
