<u>The Presidency</u> informed the SCA about the next SCA meeting on 18 January 2021 and on the "Agriculture and Fisheries" Council meeting on 25 January 2021.

<u>The Croatian delegation</u> requested an AOB item to be tabled at that Council meeting, on the recent earthquake in Croatia and its impact on the agricultural sector and on rural areas.

The Spanish delegation raised concerns about the current review of the list of Council Preparatory Bodies by the Antici group, and in particular about a possible deletion of the Chief Veterinary Officers and Chief Plant Health Officers groups from that list.
