and of the Council as regards synthetic polymer microparticles**

ANNEX

In Annex XVII to Regulation (EC) No 1907/2006, entry 78 is amended as follows:

(1) paragraph 4 is amended as follows:

(a) point (b) is replaced by the following:

	‘‘medicinal products’ as defined by Directive 2001/83/EC ⁺ or ‘veterinary medicinal products’ as defined by Regulation (EU) 2019/6 ⁺⁺ ;

(b) the following point (g) is added:

	‘synthetic polymer microparticles, on their own or in mixtures, for use in product and process orientated research and development, in quantities of one tonne per year or less;’

(2) in paragraph 5, point (c) is replaced by the following:

	‘synthetic polymer microparticles which are permanently incorporated into a solid matrix during an intended end use of a duration of one year or longer.’
