Subject: Multiannual Financial Framework (MFF) 2021-2027 and Recovery
Package: state of play of sectoral files

Following the approval of the agreement on the Multiannual Financial Framework 2021-2027 and the European Union Recovery Instrument ('Next Generation EU'), and the adoption of the respective regulations, the conditions are met for the conclusion of the negotiations related to the different sectoral files.
