The Special Committee on Agriculture encouraged the Commission to continue to monitor closely the market situation and to continue its reflections on the above mentioned two issues in the light of the Committee's discussion.

The SCA took note of the information provided by the Commission representative on some of the procedural aspects of the new arrangements in the area of comitology, as well as on the involvement of experts in the procedure on delegated acts.

The SCA also took note of the comments and observations made by a number of delegations and of the Commission representative's reaction.

The Presidency invited the Council Legal Service to respond at the next meeting to the requests made by some delegations for its views on possible procedures in the Council following adoption of a delegated act by the Commission.

The Presidency underlined the importance for the Working Parties to continue the work on the "Lisbon Adaptation" files on the basis of the discussion held.
