I. INTRODUCERE

Comisia pentru pescuit a înaintat 40 de amendamente la propunerea de regulament (amendamentele 1-40). În plus, grupul politic S&D a înaintat încă un amendament (amendamentul 41).

II. DEZBATERE

Raportorul, dl Gabriel MATO ADROVER (PPE - ES), a deschis dezbaterea, care a avut loc la 18 ianuarie 2016, și:

• a reamintit creșterea biomasei de ton roșu din ultimii ani și decizia subsecventă de a crește volumul de pescuit;

- a remarcat faptul că transpunerea recomandărilor ICCAT are drept scop asigurarea aplicării uniforme pe întreg teritoriul UE. Acest aspect a fost deja stabilit și oratorul nu a dorit să îl repună în discuție; și
- a remarcat faptul că propunerea Comisiei ar transpune modificări viitoare ale planului de refacere actual prin recurgerea la acte delegate. Comisia pentru pescuit este cu totul împotriva acestui aspect, deoarece consideră că transpunerea acestor recomandări ar trebui să fie o competență comună a Parlamentului și a Consiliului. Transpunerea ar trebui, prin urmare, efectuată prin procedura de codecizie.

Comisarul VELLA a luat cuvântul și:

- a salutat raportul Comisiei pentru pescuit, deoarece acesta conține unele sugestii pozitive;
- a salutat procesul de redresare a stocului de ton roşu, dar a atras atenția asupra pericolului de slăbire a vigilenței. Planul de redresare al ICCAT conține măsuri esențiale. Multe dintre dispozițiile planului sunt direct aplicabile în toate statele membre, însă transpunerea este necesară pentru a se asigura conformarea persoanelor fizice şi juridice. UE trebuie nu numai să își respecte obligațiile internaționale, ci şi să își mențină credibilitatea în gestionarea durabilă a pescuitului;
- și-a exprimat încrederea că se va putea rezolva divergența dintre Parlament și Comisie cu privire la interpretarea competențelor instituțiilor atunci când se transpun dispoziții ale organizațiilor regionale de gestionare a pescuitului;
- a afirmat că Comisia este ferm convinsă că ar trebui să dispună de competența de a adopta acte delegate. Acest lucru se datorează frecvenței modificărilor aduse planului de refacere a stocurilor în cadrul ICCAT și necesității de a încorpora prompt în legislația UE toate modificările viitoare. Procedura de codecizie împiedică foarte adesea punerea în aplicare a unor noi măsuri în timp util, cum ar fi necesar pentru asigurarea faptului că UE își respectă obligațiile internaționale. Actele delegate ar modifica numai elemente neesențiale ale actelor legislative. Acest lucru necesită consultări adecvate, inclusiv la nivel de experți. Aceasta necesită, de asemenea, transmiterea în timp util și într-o manieră adecvată a documentelor relevante către Parlamentul European și Consiliu; și

• a afirmat că Comisia consideră, de asemenea, că ar trebui să fie împuternicită să adopte acte de punere în aplicare, din cauza necesității frecvente de a stabili modul în care anumite măsuri din planul de redresare ar trebui să fie puse în aplicare la nivelul UE. Acest lucru este necesar în scopul creării unor condiții echitabile de concurență pentru statele membre și pentru a asigura eficacitatea acestor măsuri. Acest aspect este deosebit de relevant pentru măsurile de control introduse în cadrul ICCAT care ar putea fi interpretate în mod diferit de către diferite state membre și care sunt direct legate de cote și de alte obligații internaționale.

Luând cuvântul în numele grupului politic PPE, dl Jarosław WAŁĘSA (PPE - PL):

- a afirmat că stocurile de ton ar trebui să fie reconstituite printr-o reducere treptată a nivelurilor capturilor totale admisibile. De asemenea, este necesar să se impună limite mai stricte pentru pescuit în anumite zone şi perioade, precum şi să se introducă noi cerințe privind dimensiunile minime;
- a subliniat necesitatea de a se consolida programul ICCAT de inspecție comună internațională;
 si
- a fost de acord că aceste norme ar trebui să se aplice în mod uniform pentru a asigura condiții de concurență echitabile pentru toate părțile implicate în pescuitul de ton. Aceasta se referă la operatorii din afara UE, deoarece pescarii din UE nu ar trebui să facă obiectul unor măsuri mai stricte.

Luând cuvântul în numele grupului politic S&D, dna Renata Briano (S&D - IT) a solicitat sprijin pentru amendamentul grupului său politic, care critică monopolul actual deținut de întreprinderile mari asupra cotei de ton roșu și solicită statelor membre să revizuiască sistemul de alocare în scopul distribuirii cotelor într-un mod mai echilibrat între micii și marii operatori.

Luând cuvântul în numele grupului politic ECR, dna Ruža TOMAŠIĆ (ECR - HR) a sprijinit raportul Comisiei ca fiind bine echilibrat.

Luând cuvântul în numele grupului politic ALDE, dna Izaskun BILBAO BARANDICA (ALDE - ES):

- a solicitat un tratament egal pentru operatorii din UE și din afara UE;
- a subliniat necesitatea de a sprijini operatorii tradiționali și operatorii mici, de exemplu în Insulele Canare; și
- a solicitat ca Parlamentul să fie implicat în transpunerea recomandărilor ICCAT. Acest lucru va promova transparența, echilibrul și legitimitatea.

Luând cuvântul în numele grupului politic GUE/NGL, dna Anja HAZEKAMP (GUE/NGL — NL) a salutat progresele înregistrate până în prezent în ceea ce privește reconstituirea stocurilor de ton roșu, dar a subliniat faptul că acesta rămâne pe lista roșie a speciilor pe cale de dispariție. Prin urmare, s-a opus sprijinului oferit de Comisie si de raportor pentru cresterea limitelor de captură.

Luând cuvântul în numele grupului politic EFDD, dl Marco AFFRONTE (EFDD — IT) a subliniat dimensiunea justiției sociale și, prin urmare, a sprijinit amendamentul 41 al grupului politic S&D.

Dna Ulrike RODUST (S&D - DE):

- a solicitat criterii transparente și obiective care să fie aplicate la alocarea cotelor;
- a subliniat necesitatea ca echipamentele să fie eficiente din punct de vedere energetic și mai selective; și
- a scos în evidență nevoile speciale ale micilor operatori.

Dna Paloma LÓPEZ BERMEJO (GUE/NGL — ES) a pledat pentru o alocare corespunzătoare pentru capcana de pește de tipul "almadraba". Acest echipament este ecologic, selectiv și implică ocuparea unei forțe de muncă numeroase.

Dl Peter van DALEN (ECR - NL) a solicitat Comisiei să elaboreze un plan de conservare pentru merluciul din Marea Mediterană.

Comisarul VELLA a luat din nou cuvântul și:

- a recunoscut rolul important al pescuitului artizanal. Comisia împărtășește în mare măsură interesul Parlamentului cu privire la conservarea metodelor tradiționale de pescuit;
- a afirmat că formulările din proiectul de raport al Comisiei pentru pescuit nu sunt întotdeauna adecvate și pot induce în eroare;
- a susținut că capcanele pentru ton nu constituie singura metodă durabilă de pescuit de ton roşu sau care oferă oportunități considerabile de ocupare a forței de muncă. Acest lucru nu se reflectă în modificările propuse de comisie;
- a fost de acord că alocarea cotelor în funcție de echipamente ar trebui reevaluată în lumina circumstanțelor specifice fiecărui stat membru;

- a luat act de observatiile cu privire la almadraba si a făcut trimitere la comentariile sale referitoare la pescuitul artizanal. Comisarul a subliniat, de asemenea, că este important să se tindă către metode de pescuit ecologice și durabile;
- a recunoscut dimensiunea socio-economică. Gestionarea corectă este singura cale prin care se poate proteja sustenabilitatea, inclusiv sustenabilitatea elementelor socio-economice;
- S-a declarat de acord cu afirmatia dnei Rodust potrivit căreia cotele ar trebui să fie transparente. Toate statele membre ar trebui să urmărească acest obiectiv, alături de un nivel ridicat de selectivitate și un consum redus de energie. Pescuitul artizanal la scară mică poate juca un rol în acest proces;
- a luat act de solicitarea dlui van Dalen privind prezentarea unui plan de conservare pentru merluciu. Acest aspect poate fi discutat; și
- a reiterat poziția Comisiei potrivit căreia flexibilitatea și transpunerea rapidă necesită acte delegate, mai degrabă decât o procedură de codecizie.

Raportorul a luat din nou cuvântul și:

- a solicitat ca alocarea de cote să ofere un procentaj echitabil pentru micii operatori; și
- a respins argumentul avansat de Comisie privind actele delegate. Codecizia este procedura corectă care trebuie utilizată.

III. VOT

Cu ocazia votului în plen din 19 ianuarie 2016, Parlamentul a adoptat toate cele 41 de amendamente prezentate.

Votul cu privire la rezoluția legislativă a fost apoi amânat pentru ca propunerea să fie trimisă înapoi spre reexaminare Comisiei pentru pescuit.

Under that same provision the Commission is empowered to adopt delegated acts, for the purpose of implementing such international obligations into Union law, including, in particular, derogations from the landing obligation. Accordingly, the discard of bluefin tuna will be allowed in some situations laid down in Commission Delegated Regulation (EU) No 2015/98 of 18 November 2014. This Regulation does therefore not need to cover such discard obligations,
